

MS 348 DESCRIPTION: To cor. No. 3 Identical with Cor No. 2 Appomattox Lode Sur No. 204 also identical with Golconda location corner. Set a new pine post in same mound 4 ft. long 4 ins. square 2 ft. in the ground with mound of earth scribed G-3-348 whence.

MYERS' 2003 DESCRIPTION:

Map indicates that Myers found and accepted Mitchell's monument and restamped it with his own markings.

EVIDENCE FOUND: Found Mitchell's monument, which is a $1\frac{1}{2}$ " galvanized iron pipe with a $2\frac{1}{2}$ " brass cap, with Mitchell's markings obliterated by Myers, marked as shown, flush with ground in a 2.5 ft. diameter mound of stone. From which,

- ► A lodgepole pine, 18" diameter, dead and down, with scribing C3 348 BT visible in a partially-healed single blaze. The tree was found pushed downhill and out of it's original position by heavy equipment (MS 348 BT)
- ► A lodgepole pine, 8" dbh, bears S.73°W., 19.20 ft., with visible scribing in a partially-healed single blaze (Mitchell BT)
- ► A white fir, 12" dbh, bears S.87°W., 17.75 ft., with fully-healed single blaze (Mitchell BT)
- ► A white fir, 39" dbh, bears N.02°W., 16.5 ft., with fully-healed single blaze (MS 593 BT)

DESCRIPTION OF MONUMENTS AND ACCESSORIES SET AND METHODS USED:

I accept Mitchell's brass cap monument as a faithful and accurate perpetuation of the original corner, being harmoniously related to the found accessory evidence, and to other found accepted corners in the area.

I attached new USFS 54-3 and 54-9 signs to all live BT's. Distances to Mitchell's bearing trees were measured with a steel tape to a 60d galvanized spike with attached $1\frac{1}{2}$ " diameter aluminum washer marked PLS 699 found driven side-center-left at the root crown of each tree. Distance to the MS 593 tree measured to the side-center. Used RTK GPS to measure bearings. Bearings are geodetic, based on GPS observation taken at the corner. See associated Map of Survey dated August 20, 2025 for survey-related information.
