

ORIGINAL DESCRIPTION: Set post $4\frac{1}{2}$ ft. long 4 inches square 18 inches in the ground with mound of earth, scribed 3-367A

A fir, 14 inches diam. bears N5°E 6 ft A tamarack 30" dia bears S.46°E. 20 feet each blazed and scribed Cor. No. 3-367A B.T.

1924 G.L.O. DESCRIPTION: Corner No. 3, Old Middleman Claim, Sur. No. 367A, as described

MITCHELL'S 1980 DESCRIPTION:

DESCRIBE CORNER MONUMENT FOUND: Rotted post in md of earth.

DESCRIBE BEARING TREES OR OTHER OFFICIAL ACCESSORIES FOUND: Large WL stump w/ scribing brs S46°E, 26 ft. MONUMENT: DESCRIBE NEW MONUMENT SET, OR WORK DONE TO PRESERVE EXISTING MONUMENT: Set $2\frac{1}{2}$ " B.C. on 32" 1" gal. pipe in original md marked OM3 MS 367A 1980

ACCESSORIES: DESCRIBE NEW BT'S WITNESS OBJECTS ETC. ESTABLISHED, OR WORK DONE TO PRESERVE EXISTING EVIDENCE: 10" DF brs N74°E 20'; 9" WF brs N63°W 19' Both marked OM 3 MS 367 B.T.

EVIDENCE FOUND: Found Mitchell's unrecorded monument, which is a $1\frac{1}{2}$ " galvanized iron pipe with a $2\frac{1}{2}$ " brass cap, marked as shown below, flush with the ground in $1\frac{1}{2}$ ft. diameter collar of stone. From which, I found Mitchell's bearing tree:

► A Douglas-fir, 12" diam., dead and down (broken off), with visible scribing in a partially healed blaze. Center of the stump bears N.71°E., 20 ft.

I searched for, but found no remains of Mitchell's second BT or the original BT's. The area has been logged heavily in the past.

DESCRIPTION OF MONUMENTS AND ACCESSORIES SET AND METHODS USED:

I accept the brass-capped monument as the best available evidence of the original corner.


From which, I SCRIBE A NEW BEARING TREE:

► A lodgepole pine, 9" dbh, bears S.57°E., 29.79 ft. marked *OM 3 367* in upper blaze, and *XBT* in lower blaze.

Also from which, I SET A NEW REFERENCE POINT:

► A 5/8"x 24" iron pin, bears S.83°34'W., 12.62 ft., with attached 2" aluminum cap marked *RP 1 2023 PLS 69454*

CORNER MONUMENT MARKED:



Painted a 6 inch red band around the new bearing tree, painted the blazes red, and attached USFS 54-3 and 54-9 signs. Used a magnetic compass with 14° East declination to measure bearings to BT's. Distances were measured with a steel tape. Distance to new BT was measured with a steel tape to a 60d nail driven in the side-center-right at the root crown of the tree, with an attached $1\frac{1}{2}$ " aluminum washer stamped PLS 69454.
