## History of original corner establishment:

Corner established by John Hagel, U.S. Deputy Mineral Surveyor, under instructions received from the United States Surveyor General for Oregon dated Oct. 19, 1899, and designated as Survey No. 378.

Surveyor General records state:

Beginning at Cor. No. 1, a post previously described identical with the S.W. location Cor. identical with Cor. No. 6 Charleston Lode.

A tamarack tree, 15 ins. in diam., bears N82°45'W, 50.0 ft. A tamarack tree, 10 ins. in diam., bears N47°40'W, 58.0 ft. Both blazed and marked Tel. C. 1–378 BT.

Corner was perpetuated by: John Hagel, U.S. Deputy Mineral Surveyor, under instructions dated Nov. 28, 1900, and designated as Survey No. 378 Amended.

Record states:

Beginning at Cor. No. 1, identical with Cor. No. 1 of the original survey, a tamarack post 4 ins. square 4 1/2 ft. long, set 18 ins. in the ground with a mound of earth around it, marked TEL. C. 1-378.

A tamarack tree, 15 ins. in diam., bears N82\*45'W, 50.0 ft. A tamarack tree, 10 ins. in diam., bears N47\*40'W, 58.0 ft. both blazed and marked TEL. C. 1-378 BT.

Corner was remonumented by: John R. Mitchell, an unlicensed Forester, as described by USFS Corner Card.

Record states:

Piece of 4 x 4 post w/ scribing, in poor condition, marked 378.

30" (green) larch brs N82°45'W, 50 ft., scribing partially grown over. 12" (down) larch brs N47°40'W, 58 ft., with full scribing.

Corner was perpetuated by: Leland Myers, per Baker County Survey 8-37-135/9-37-279 in 2003. No Corner Record for this Monument was found. It is apparent Myers accepted the Mitchell brass cap and stamped his number and date over the top of Mitchell's.


