


SURVEYOR'S CERTIFICATE

I, James D. Hanley certify that I have correctly surveyed and platted two parcels of land on the annexed partition map in accordance with O.R.S. Chapter 92 and the instructions of the owners. The boundary of this partition is described as follows:

A tract of land in the North half of Lot 2 of the Southwest quarter of Section 30, Township 8 South, Range 39 East of the Willamette Meridian in the County of Baker, State of Oregon, more particularly described as follows:

Beginning at the Northwest corner of the North half of said Lot 2; thence N. 89° 48′ 12″ E., 490.75 feet; thence S. 0° 18′ 21″ E., 1231.13 feet to the Northerly line of the former 40 feet wide Baker County Pine Creek Road; thence along a 81.62 feet arc of a 592.96 foot radius curve left the chord of which bears N. 71° 29' 06" W., 81.56' feet; thence N. 75° 25' 20" W., 350.32 feet along the said road; thence along a 80.84 feet arc of a 2884.79 foot radius curve left the chord of which bears N. 76° 13' 24" W., 80.83' feet to intersect the West line of the said Section 30; thence N. 0° 07' 36" W.. 1096.11 feet along the section line to the point of beginning. The partition contains 13.12 acres.

I performed the survey and prepared the plat by order of and under the direction of the owners. All parcel and boundary corners are marked in accordance with O.R.S. Chapter 92.050 and 92.060.

The purpose of this survey for Virgel L. and Dorls A. Kelthley is to repartition Parcel No. 1 of Partition P 1990-011 into two parcels identified hereon as Parcel No. 1 and Parcel No. 5 of this current partition plat in conformance with article 10 of Baker County Zoning and Subdivision Ordinance. Monumentation was recovered from P 1994-001 and bearings held for this subject survey. County road alignment data is from Meadowbrook West Subdivision Plat.
