

NARRATIVE

This partition was done at the request of Greg Sackos, owner of the land within. Mr. Sackos wanted to divide the property as shown. I recover monuments of Summerfield West Subdivision and find them very harmonious with the plat. At the Southeast corner, I find the pin removed and replace this as per platted location. I find no unusual conditions with this partition.

 10 ft. wide utility easement, granted to Oregon Trail Electric Consumers Cooperative, by instrument dated January 25, 1991, recorded February 12, 1991 in Deed 91 07 071. Placed as per legal description easement falls within Stubblefield Road easement.
- Access easement, 30 feet in width, and cul—de—sac, as shown on the Plat of Summerfield West Subdivision SD1996—001, recorded in Deed 96—34—132, shown as Summerfield Road hereon.
- All matters relating to the gravel pit located on Parcel 1, as shown on the Plat of Summerfield West Subdivision
- Protective Covenants, Conditions and Restrictions for Summerfield West, recorded August 21, 1996 in Deed 96 34 135, records of Baker County, Oregon.
- Sewage disposal shall be through a DEQ approved sanitary sewage disposal system
