

## BASIS OF BEARINGS

RECORD MAP OF SURVEY NO. 8-40-14 THE NORTH-SOUTH CENTER LINE OF SECTION 34 BEARS NO1°37'13"W AS SHOWN

**NARRATIVE** 

THIS SURVEY WAS PERFORMED AT THE REQUEST OF THE TONY AND BENITA BRITT ACTING ON BEHALF OF NORTHWEST LAND RESOURCES, LLC. THE PURPOSE OF THIS SURVEY WAS TO MONUMENT THE CORNERS OF THE DEPARTMENT OF GEOLOGY AND MINERAL INDUSTRIES (DOGAMI) PERMIT NO. 01-0063, BEING IDENTICAL WITH A PORTION OF THAT CERTAIN PROPERTY DESCRIBED IN DEED NO. BO3 25 0232, BAKER COUNTY DEED RECORDS. THIS REQUIRED A DEPENDENT RESURVEY AND SUBDIVISION OF

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. THE EXTERIOR BOUNDARY OF THE TOWNSHIP WAS ORIGINALLY SURVEYED BY TIMOTHY W. DAVENPORT, U.S. DEPUTY SURVEYOR UNDER CONTRACT NO. 102 DATED JULY 20, 1863. THE SUBDIVISION OF TOWNSHIP 8 S., RANGE 40 E. WAS COMPLETED BY DAVID P. THOMPSON AND DAVID CHAPLIN. U.S. DEPUTY SURVEYORS, UNDER CONTRACT NO. 104 DATED APRIL 16, 1864. A SEARCH OF THE BAKER COUNTY SURVEYOR'S RECORDS PRODUCED SURVEY NO.'S 8-40-6, 8-40-10, 8-40-14, 8-40-15, 8-40-20, 9-40-13, 9-40-25 AND 9-40-558. I ALSO FOUND INFORMATION CONCERNING THE ESTABLISHMENT OF COUNTY ROAD NO. 751 IN SURVEYOR RECORD BOOK 1, PAGE 125.

A SEARCH OF THE DEED RECORDS REVEALED THAT IN 1963 BAKER COUNTY ACQUIRED PROPERTY FOR THE RIGHT OF WAY OF SOUTH AIRPORT LANE (COUNTY ROAD NO. 741). I FOUND THAT THE 60 FOOT WIDE RIGHT OF WAY IS NOT CENTERED ON THE SECTION LINE, AS IS THE COMMON SITUATION. IN THE CASE OF SOUTH AIRPORT LANE, LANDOWNERS TO THE SOUTH CONVEYED THE NORTH 37 FEET OF THEIR PROPERTY AND LANDOWNERS TO THE NORTH CONVEYED THE SOUTH 23 FEET OF THEIR PROPERTY IN 1983, JIM HANLEY, PLS, PERFORMED SURVEY NO. 8-40-6, WHERE HE DETERMINED THE LOCATIONS OF THE CONTROLLING CORNERS OF SECTION 34. THE ORIGINAL MONUMENTS AT THE NORTH QUARTER CORNER AND NORTHEAST CORNER OF SECTION 34 WERE OBLITERATED BY THE ROAD. AS RURAL COUNTY ROADS ARE TYPICALLY CENTERED ON SECTION LINES, THE RIGHT WAY FENCES ARE OFTEN THE BEST AVAILABLE EVIDENCE OF THE LOCATION OF THE SECTION LINES AND CORNERS. AS SUCH, MR HANLEY REESTABLISHED THESE CORNERS MIDWAY BETWEEN RIGHT OF WAY FENCES, WHICH IS A COMMONLY ACCEPTED PRACTICE. HOWEVER, IN THIS CASE IT SEEMS THE 1963 RIGHT OF WAY DEEDS MAY HAVE BEEN OVERLOOKED. THESE DEEDS ARE A CRITICAL PIECE OF EVIDENCE IN DETERMINING THE LOCATION OF THIS SECTION LINE. I BELIEVE THAT IF MR. HANLEY WOULD HAVE HAD KNOWLEDGE OF THESE RIGHT OF WAY DEEDS, HE WOULD HAVE REESTABLISHED THE CORNERS ACCORDINGLY. THIS PROBLEM SEEMS TO BE ISOLATED TO THE NORTH HALF OF SECTION 34, SINCE THE EAST—WEST CENTER LINE OF SECTION 34 IS BASED ON FOUND EVIDENCE AT THE EAST AND WEST QUARTER CORNERS, AND WILL NOT CHANGE. BAKER COUNTY SURVEY NO. 8-40-10 PERFORMED BY JIM HANLEY IN 1985 IS THE ONLY SUBSEQUENT SURVEY OF RECORD THAT I FOUND IN WHICH CORNER POSITIONS WILL BE AFFECTED. I HAVE DISCUSSED MY FINDINGS WITH TOM HANLEY OF HANLEY ENGINEERING AND CURRENT BAKER COUNTY SURVEYOR. THE MONUMENTS FROM SURVEY NO. 8-40-6 AT THESE TWO LOCATIONS ARE LEFT IN PLACE, BUT HAVE BECOME REFERENCES TO THE NORTH QUARTER CORNER AND NORTHEAST CORNER OF SECTION 34. NEW MONUMENTS WERE SET AT BOTH CORNERS TO ACCOUNT FOR THE 7 FOOT DIFFERENCE, AS SHOWN.

THE RIGHT OF WAY OF SUNNYSLOPE ROAD WAS ORIGINALLY 60 FEET WIDE, AND CENTERED ON THE EAST LINE OF SECTION 35 ACCORDING TO BAKER COUNTY SURVEYOR'S RECORD BOOK 1, PAGE 125. IN 1981, AN ADDITIONAL 20 FEET OF RIGHT OF WAY WAS ACQUIRED BY BAKER COUNTY AS EVIDENCED BY DEED NO. 81 38 001.

WE MADE FIELD MEASUREMENTS TO SEARCH FOR MONUMENTS SET DURING SURVEY NO. 8-40-10, BUT FOUND ONLY TWO REMAINING. ONE WAS FOUND AND ACCEPTED AT THE RIGHT OF WAY INTERSECTION OF SOUTH AIRPORT LANE AND LINDLEY ROAD. DUE TO THE 7 FOOT DIFFERENCE IN THE NORTH LINE OF THE NE1/4 SECTION 34 AS DISCUSSED PREVIOUSLY, THE OTHER MONUMENT WAS FOUND SOUTH 3.5 FEET FROM THE CORNER, AND IS NOT ACCEPTED. WE ALSO SEARCHED FOR THE MONUMENT SET DURING SURVEY NO. 8-40-6 AT THE CENTER-NORTH 1/16 CORNER BUT FOUND NO TRACE OF IT. I ACCEPT THE FOUND MONUMENTS OF RECORD AT THE EAST QUARTER CORNER, SOUTHEAST CORNER, THE SOUTH QUARTER CORNER AND THE WEST QUARTER CORNER SECTION 34. THE FOLLOWING CONTROLLING CORNERS OF SECTION 35 WERE REESTABLISHED ACCORDING TO THE

N1/4 CORNER SECTION 35
EXISTING RIGHT OF WAY FENCES WERE ACCEPTED FOR THE LOCATIONS OF THE RIGHT OF WAY LINE AND 23 FEET SOUTH OF THE QUARTER CORNER WAS THEN REESTABLISHED 37 FEET NORTH OF THE SOUTH RIGHT OF WAY LINE AND 23 FEET SOUTH OF THE NORTH RIGHT OF WAY LINE (PER 1963 RIGHT OF WAY DEEDS), AND IN LINE WITH A LONG-ESTABLISHED FENCE RUNNING

EXISTING RIGHT OF WAY FENCES WERE ACCEPTED FOR THE LOCATIONS OF THE RIGHT OF WAY LINES OF SUNNYSLOPE ROAD. THE CORNER POSITION WAS DETERMINED AT 30 FEET EAST OF THE WEST RIGHT OF WAY LINE OF SUNNYSLOPE ROAD, AND 37 FEET NORTH OF SOUTH RIGHT OF WAY LINE OF SOUTH AIRPORT LANE (PER 1963 RIGHT OF WAY DEEDS). I DETERMINED THE LOCATION OF THIS CORNER FOR ADDITIONAL SUPPORTING EVIDENCE, AND I DID NOT MONUMENT IT FOR THIS SURVEY.

### EAST 1/4 CORNER SECTION 35 EXISTING RIGHT OF WAY FENCES WERE ACCEPTED FOR THE LOCATIONS OF THE RIGHT OF WAY LINES OF SUNNYSLOPE ROAD. THE QUARTER CORNER WAS THEN REESTABLISHED 30 FEET EAST OF THE WEST RIGHT OF WAY LINE AND 50 FEET WEST OF THE EAST RIGHT OF WAY LINE (PER SURVEYOR RECORD BOOK 1, PAGE 125 AND DEED NO. 81 38 001), AND IN LINE WITH AN OLD FENCE RUNNING EAST.

### SOUTHEAST CORNER SECTION 35

I FOUND THE EAST REFERENCE MONUMENT, WHICH IS A 5/8" REBAR WITH NO CAP IN THE EAST RIGHT OF WAY FENCE. I ALSO FOUND THE WEST REFERENCE MONUMENT, ALSO A 5/8" REBAR WITH NO CAP, WHICH WAS BADLY BENT AND OUT OF POSITION. ALTHOUGH THE ORIGIN OF THESE MONUMENTS IS UNKNOWN, THEY HAVE BEEN UTILIZED AS REFERENCES TO THE SECTION CORNER ON SURVEY NO.'S 9-40-13, 9-40-25 AND 9-40-558. I REESTABLISHED THE SECTION CORNER AT THE RECORD BEARING AND DISTANCE OF S.89'16'05"W., 28.91 FEET FROM THE EAST REFERENCE MONUMENT. I ALSO FOUND AN UNRECORDED 1/2" IRON PIN WITH YELLOW CAP 0.14' NORTH AND 0.20' EAST, WHICH IS NOT ACCEPTED.

### SOUTH 1/4 CORNER SECTION 35

WE FOUND THE PIPE WITH BRASS CAP FROM SURVEY NO. 9-40-25 LAYING ON THE GROUND AND BENT. IT APPEARED THAT IT HAD BEEN PULLED OUT OF THE GROUND, POSSIBLY BY HEAVY EQUIPMENT. AS THERE WERE NO REFERENCES OF RECORD FOR THIS CORNER, WE REMOVED THE OLD MONUMENT AND SET A NEW MONUMENT BY SINGLE PROPORTIONATE MEASURE BETWEEN THE FOUND MONUMENT AT THE SOUTHWEST CORNER OF SECTION 35 AND THE REESTABLISHED MONUMENT AT THE SOUTHEAST CORNER

NEW MONUMENTS WERE SET ACCORDING TO THE EVIDENCE FOUND AND THE PROCEDURES OUTLINED HEREIN. SECTIONS 34 AND 35 WERE SUBDIVIDED WITH REFERENCE TO THE 2009 B.L.M. MANUAL. SEE MONUMENTATION SHEETS FILED SEPARATELY FOR MORE
