

ORIGINAL DESCRIPTION: Set qr Sec post and made mound of earth and drove charred stake as per inst.

SURVEY NO. 9-40-25: Set 21/2" brass cap monument "apportioned location"

EVIDENCE FOUND: We found a 1½" pipe with 2½" brass cap from Survey No. 9-40-25 laying on the ground and bent. It appeared that it had been pulled out of the ground by heavy equipment. As there were no references of record for this corner, I reestablished the position by single proportionate measure between the found monument at the southwest corner of Section 35 and the reestablished monument at the Southeast corner of Section 35.

DESCRIPTION OF MONUMENTS AND ACCESSORIES SET AND METHODS USED:

At the corner point, I set a 5/8"x30" iron pin with attached 2" aluminum cap 30" in the ground. Cap is marked as shown below.

From which, I SET THE FOLLOWING REFERENCE POINTS:

- ► A 5/8"x30" iron pin bears N.59°06'E., 23.05 ft. with attached yellow plastic cap marked BENCHMARK SURVEYING.
- ► A 5/8"x30" iron pin bears S.45°06'E., 28.64 ft. with attached yellow plastic cap marked BENCHMARK SURVEYING
- ► A 5/8"x30" iron pin bears S.28°58'W., 13.14 ft. with attached yellow plastic cap marked BENCHMARK SURVEYING, in a North-South fence.
- ► A 5/8"x30" iron pin bears N.24°01'W., 17.12 ft. with attached yellow plastic cap marked BENCHMARK SURVEYING, set in a North-South fence.



Used RTK GPS to measure the reference points. Bearings are based on Baker County Survey No. 8-40-14.
