At position of found 4"x6" partially rotted wood post in small rock mound, set a 5/8" x 30" steel rebar.

I replaced Willaim Hanley's rebar with a 2 $\frac{1}{2}$ " x 32" brass capped steel pipe set 28 ins. in the ground.

A white fir, 10 ins. diam., bears N. 721/4° W., 14.97 ft., mkd. COR 3/MS 11 BT.

Description of corner evidence found:


Found a 2% ins. diam. steel pipe with a 2% ins. diam. brass cap, firmly set, 2 ins. above ground, in rock collar, mkd. as shown,

From the recovered monument I find the bearing trees mkd. by Hildebrand

Remains of a white fir stump, bear S. 22% E., 13.0 ft. dist. to stump hole, with dead and down fir alongside with visible scribe on open blaze. (S. 22½° E., 14.2 ft., Hildebrand)

A white fir, 16 ins. diam., dead and down, bears N. 72¼° W., 15.0 ft. dist., with healed blaze.

Found guard post 3 ft. west with Land Survey Monument (54-9) sign.
