Description of corner evidence found:

Found: A basalt stone 13"x8"x7" (record states $15 \times 10 \times 8"$) loose on the ground with 2 notches and 1 notch marked on adjacent edges and with a steel fence post alongside and BLM location tag under stone by WKD dated 1983.

Description of monument and accessories I established to perpetuate the original location of this corner:

At position of found stone...Set an $2\frac{1}{2}$ " aluminum cap on 2" aluminum pipe 30" long 20" in the ground to bedrock with 10" projecting out of ground with surrounding rock mound and attached sign 54-9 to fence post alongside. Buried original stone alongside aluminum monument.

There being no suitable trees within limits, I marked the following bearing object... A basalt boulder 40"x 24" x 20" bears N71°E, 111.5' dist marked "BXO"...and there being no other suitable bearing objects available within limits I established the following reference monument...A 5/8" x 30" rebar driven "to refusal" bears N54°W, 26.1' dist with a 1½" diam aluminum cap attached and marked thus:
