OFFICER ADDITION TO HALFWAY SHOWED FIR STREET AS A VARIABLE WIDTH STREET, IMPLYING PLAT DISTANCES HELD, AND ALL EAST-WEST ERROR PUT IN SAID FIR STREET. PARTITION LINE WAS SET AS PER CLIENT'S INSTRUCTIONS. SURVEY WAS PERFORMED USING A PENTAX III-10 TOTAL STATION.

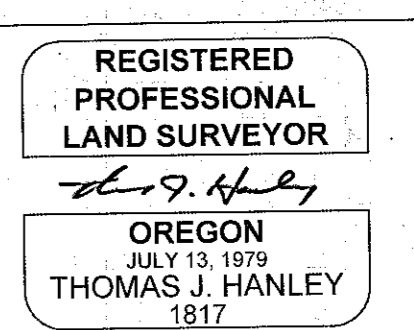
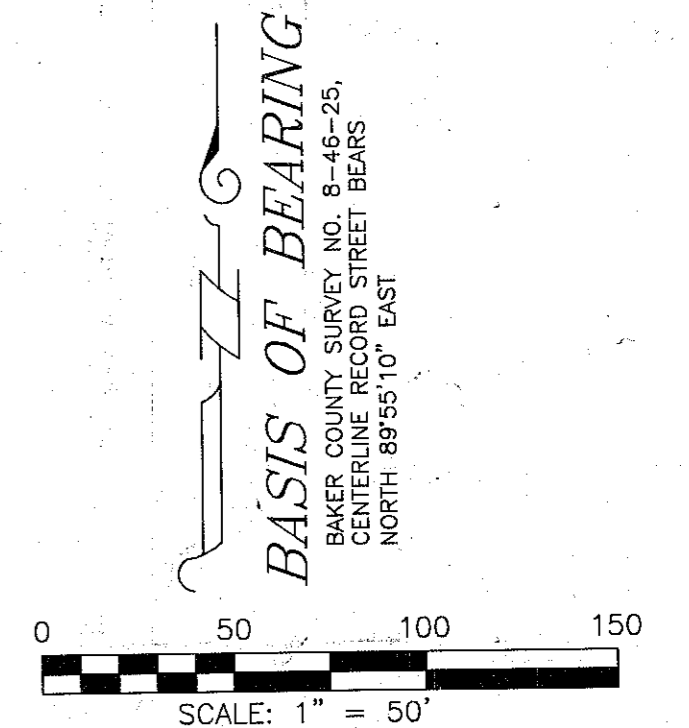
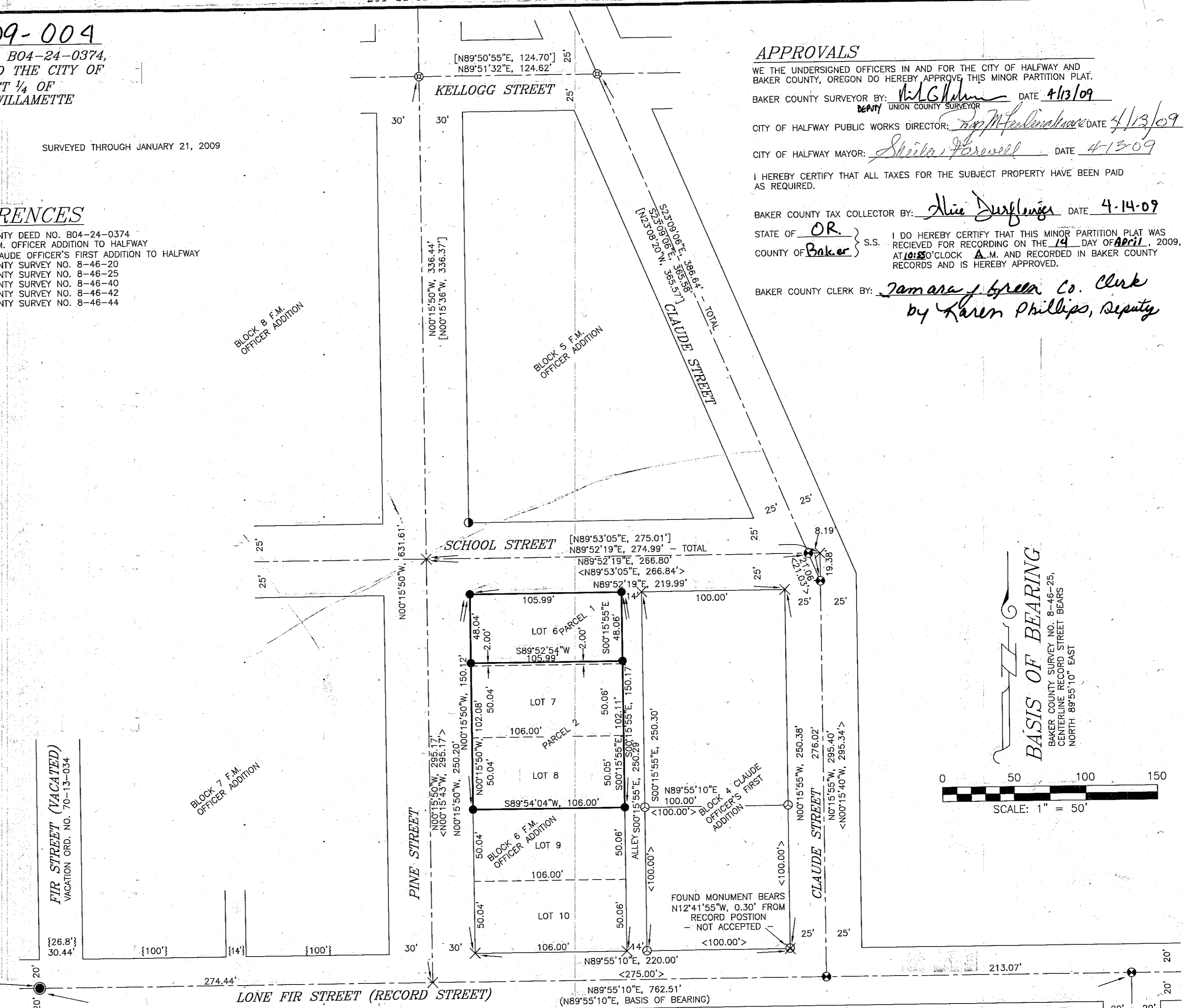
