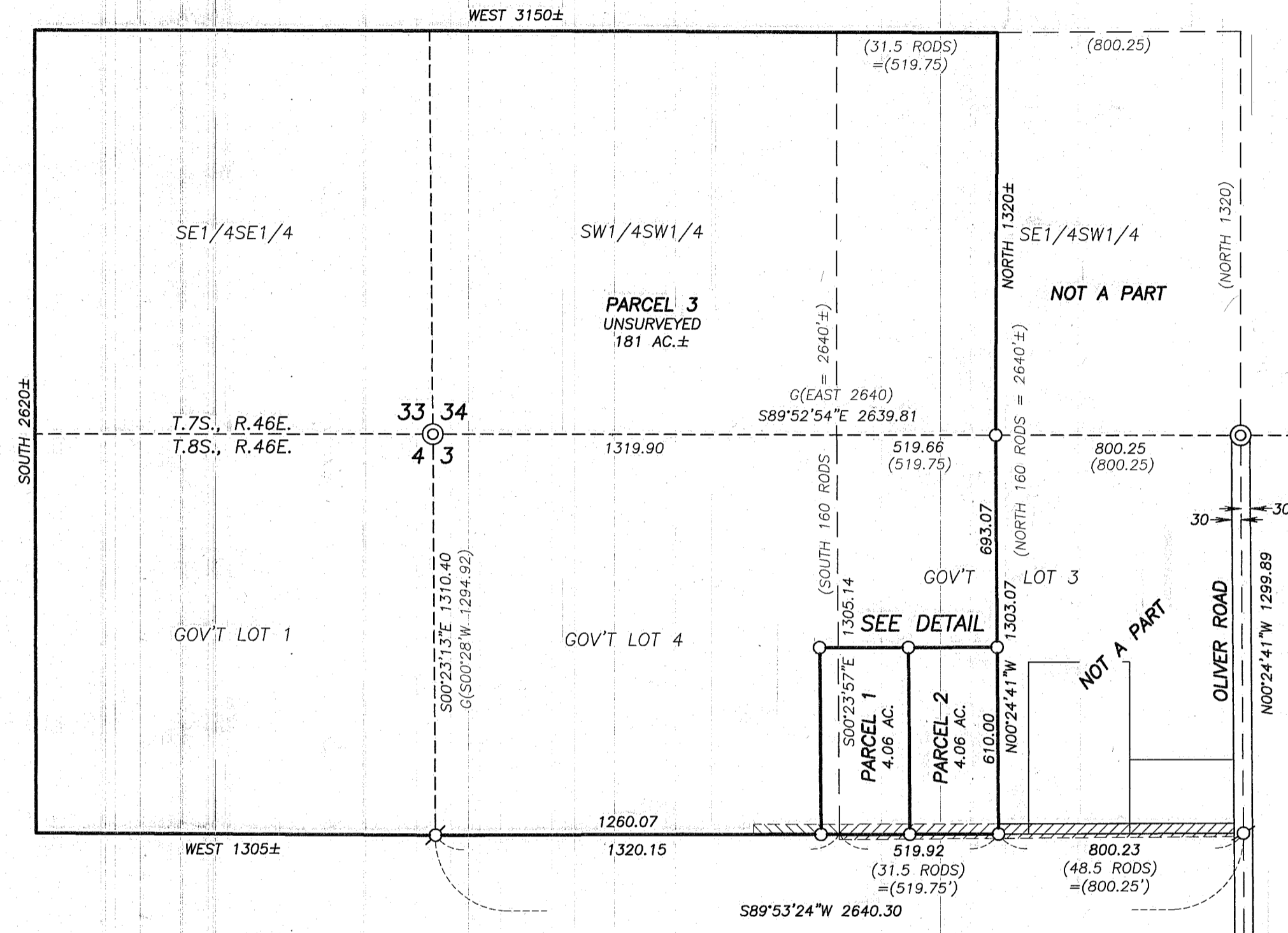

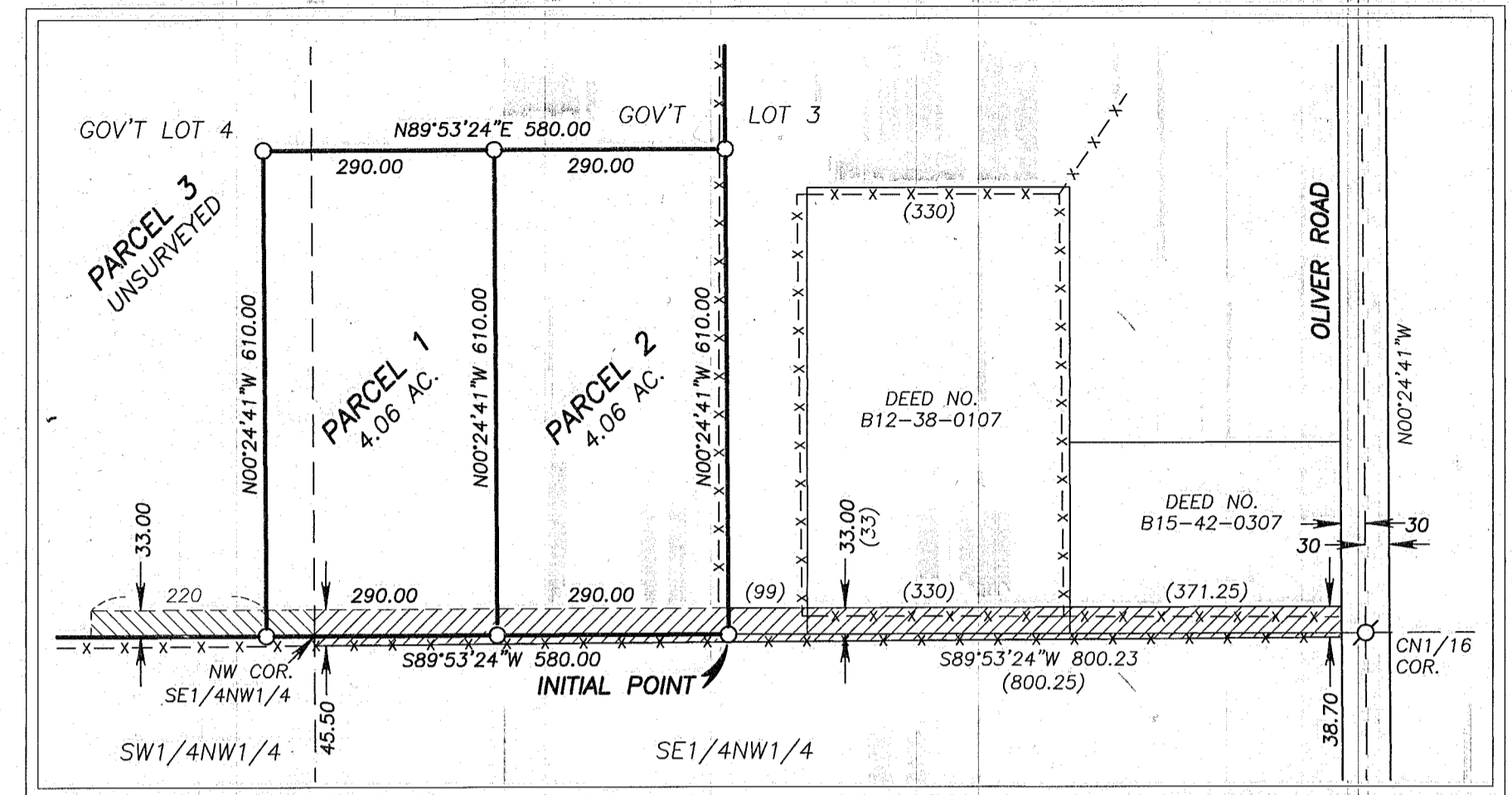

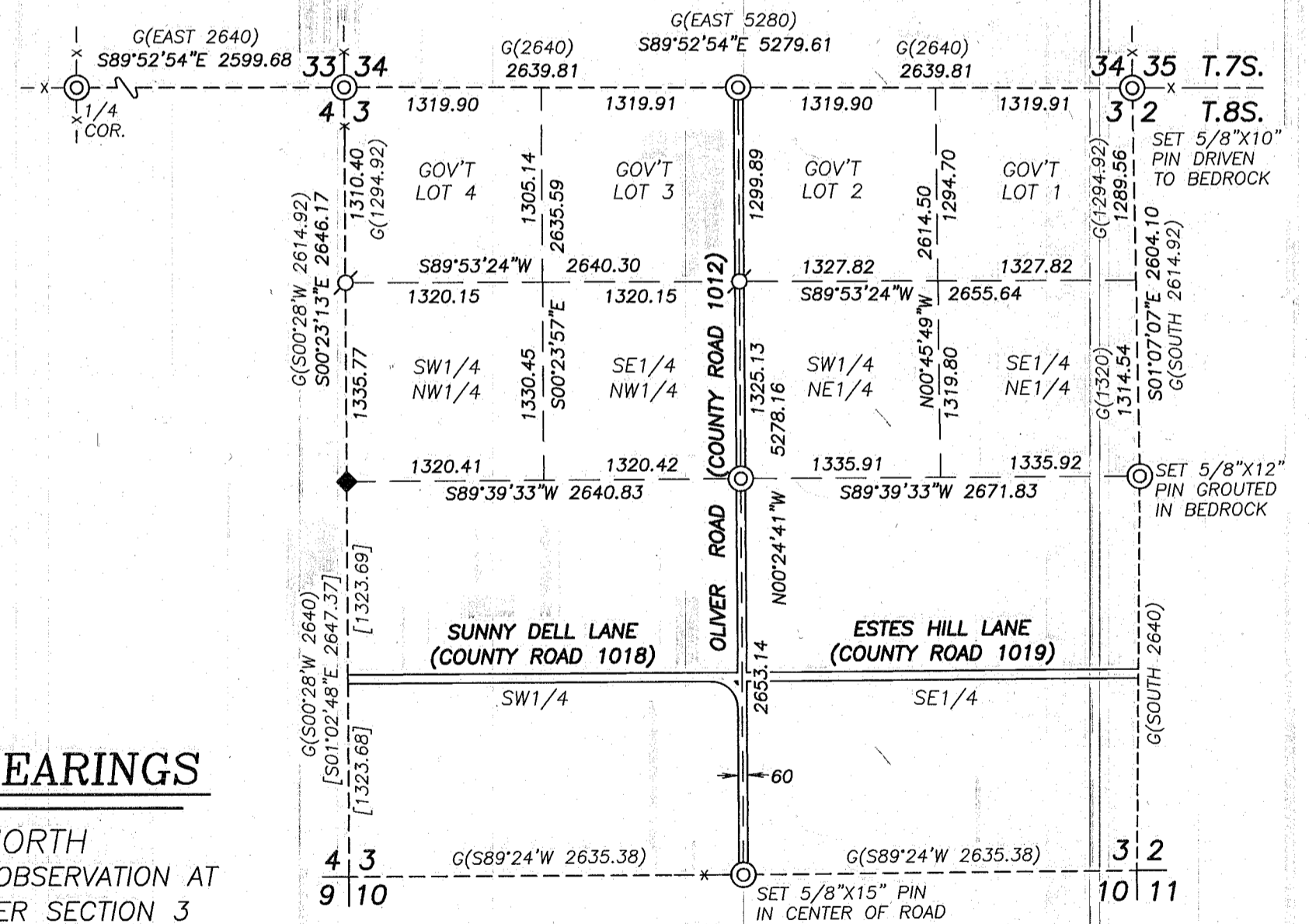

SCALE: 1"=1000'



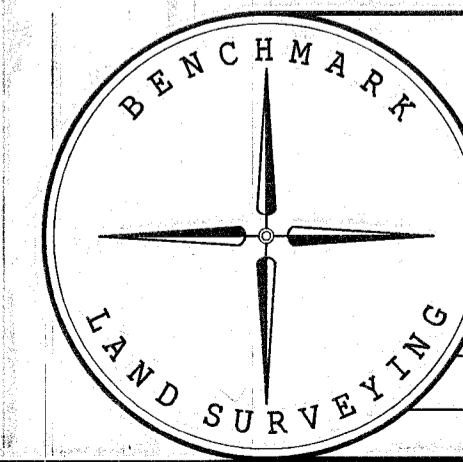
