

## NARRATIVE

THIS MAP OF SURVEY WAS PREPARED AT THE REQUEST OF KYLE RANSOM OF RICHLAND FEED AND SEED, INC. THE PURPOSE IS TO SHOW A PROPOSED PROPERTY LINE ADJUSTMENT BETWEEN PROPERTIES DESCRIBED ON DEED NO.'S 12220154 AND 07470225.

IN DECEMBER OF 2018, I PERFORMED A BOUNDARY SURVEY OF THE PROPERTY OWNED BY RICHLAND FEED AND SEED, INC., WHICH WAS FILED AS SURVEY NO. 8-46-158. AT THAT TIME AND AT MR. RANSOM'S REQUEST, I SET AN ADDITIONAL MONUMENT IN PREPARATION FOR THIS PROPERTY LINE ADJUSTMENT. TO PERFORM ANOTHER FIELD SURVEY FOR THIS PROPERTY LINE ADJUSTMENT WHEN ALL POINTS HAVE ALREADY BEEN RECENTLY MONUMENTED WOULD BE UNNECESSARILY REDUNDANT. THEREFORE, ALL INFORMATION SHOWN HEREON WAS DERIVED FROM SURVEY NO. 8-46-158, WHICH PROVIDES THE BASIS OF BEARINGS AND ALL OF THE CONTROLLING MONUMENTS NECESSARY.

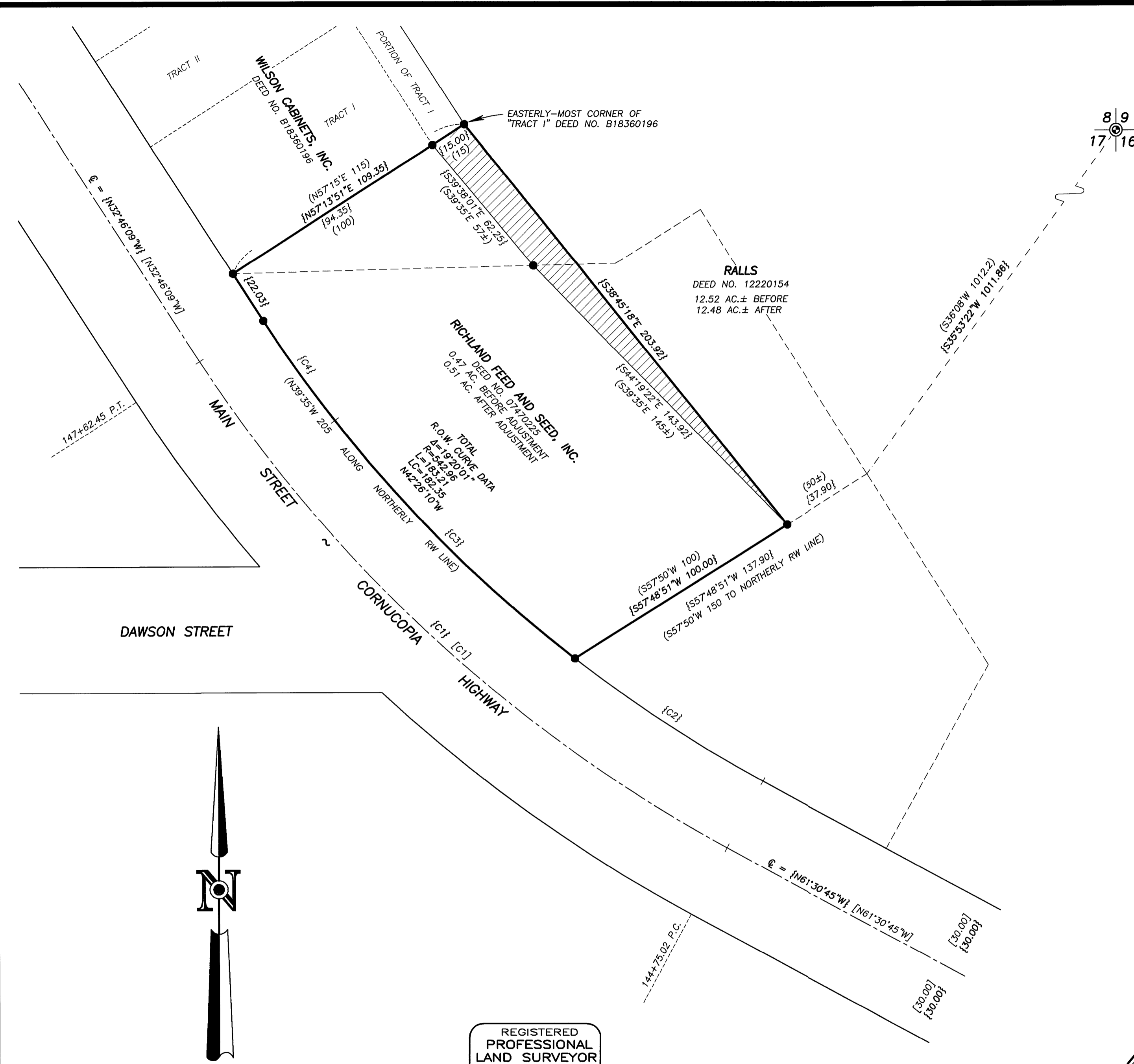
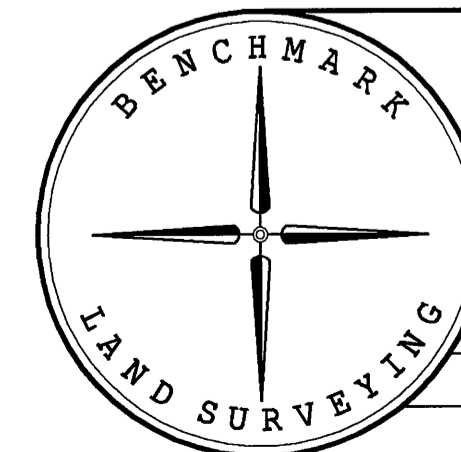
