

NARRATIVE

THIS PARTITION WAS PERFORMED AT THE REQUEST OF PINE EAGLE SCHOOL DISTRICT #61 FOR THE PURPOSE OF PARTITIONING PARCEL 3 OF PARTITION PLAT 2004-03 INTO THREE (3) NEW PARCELS, AS SHOWN HEREON.

THE MONUMENTS OF RECORD WHICH ARE THE SOUTHEAST, SOUTHWEST AND NORTHWEST CORNERS OF PARCEL 3, AND TWO (2) ADDITIONAL SURVEY MONUMENTS ALONG THE SOUTH AND WEST LINES OF PARCEL 3; HAVE BEEN DISTURBED DUE TO FENCE BUILDING AND EARTHWORK ACTIVITY. THE INTACT POSITIONS OF THESE MONUMENTS WERE MEASURED DURING PARTITION PLATS 2021—001 AND 2021—010. THE 2021 POSITIONS WERE HERE HELD FOR THIS SURVEY.

THE NORTHEAST CORNER OF PARCEL 3 WAS PROPORTIONED ALONG THE EAST LINES PARCELS 2 AND 3 OF PARTITION PLAT 2003—018 USING THE ORIGINAL NORTHEAST CORNER OF PARCEL 2, A 1/2 INCH IRON ROD, AND THE ABOVE—MENTIONED SOUTHEAST CORNER OF PARCEL 3. THE CONFIGURATION OF THE NEW PARCELS WERE ESTABLISHED AT THE DIRECTION OF THE SCHOOL DISTRICT, TOGETHER WITH ADDITIONAL MONUMENTS SET AT THEIR DIRECTION.

THIS WORK WAS ACCOMPLISHED WITH TRIMBLE R-8 G.P.S. RECEIVERS AND A NIKON DTM 522 THEODOLITE WITH ELECTRONIC DISTANCE MEASURING CAPABILITY.
