## CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner was originally established by E. McCormack under G. L. O. contract No. 398, during September 28, 1881. Surveyors General's notes state: "Set post 4 ft. long 4 ins. square 24 ins. in the ground for corner to Sec's. 13 - 18 - 19 & 24 marked:

T9S S18 on NE, R37E S19 on SE, R36E S24 on SW and
S13 on N. W. face, with 3 Notches on N. and S. edges
from which, A pine 30 ins. diam. bears N65°E, 36

1ks. dist. marked T9SR37ES18 BT. A pine 10 ins. diam. bears S70°E,

## Description of corner evidence found:

Found no trace of record corner post. Found a 20" pine stump with scribed BT. Measured S85°E, 8.0 ft. and S73°E, 39.4 ft. found rotton stump hole, and down and rotton 14" pine with full faint scribing. No trace of the Southwest and Northeast BTs could be found.

Corner falls in old skid road, about 100 ft. East of a drain on West slope.

## Description of monument and accessories I established to perpetuate the original location of this corner:

At the center of the above described point, set 2 1/2" X 30" galvanized pipe and brass cap marked: Set pipe 25" in the ground and mound of stone around to cap. By which by magnetic declination of N20°E:

A 12" Pine bears N23°E, 15.0 ft. scribed T9SR37ES18

BT. A 12" Pine bears S87°E, 28.0 ft. scribed T9SR37ES19 BT. A 15" Pine bears S08°W, 42.0 ft. scribed T9SR36ES24 BT. A 10" Tamarac bears N61°W, 53.4 ft. scribed T9SR36ES13 BT. Placed 54-3s and brass washers stamped PLS 1051 on the BTs. Placed 54-3 on the old BTs. Painted blazes red and 6" red band around. Placed 54-4 on a steel fence post 5' North of the corner.
