the badly weathered remains of old wood post loosely set with scribe marks not legible, at point for cor...Set an iron post 3ft long lin dia 27ins in ground with marked stake deposited at the base for \$\frac{1}{4}\$ sec cor of sec 1 only with brass cap marked (as shown in corner diagram) from which: A fir stump 12 ins dia bears N75 W, 29 lks dist marked \$\frac{1}{4}\$S BT obliterate marks, old BT. A fir 36 ins dia bears S55 W, 13 lks dist marks grown over, old BT. A fir 6 ins dia bears S52 E, 37 lks dist marked \$\frac{1}{4}\$S1 BT, new BT.

## Description of corner evidence found:

Found a  $2\frac{1}{2}$ " brass cap on 1" iron post protruding 4" from mound of earth marked as shown in corner diagram.

A fir 29 ins dia bears  $S55^{\circ}W$ , 8.6 ft with healed blaze (old BT) A fir 10 ins dia bears  $S52^{\circ}E$ , 23.7 ft with healed blaze.

## Description of monument and accessories I established to perpetuate the original location of this corner:

Corner monument maintained to USFS standards as follows...cleared brush and debris from around cor monument. Placed 6' steel fence post E of cor with sign 54-9 attached.

Each original bearing tree has signs 54-3 and 54-9 attached below a 6 inch band of red paint.

Compass declination 19 East.
