SURVEYOR GENERAL'S RECORD STATES:

A pine post 4.5 ins. square, 4 ft. long, set 1.5 ft. in the ground with a mound of earth and stone, scribed 4-813-PACIFIC, whence A red fir 14 ins. dia. bears S10E., 5.42 ft., and A black pine 10 ins. dia. bears N57E., 48.4 ft., each blazed and scribed 4 813 PACIFIC BT.

B. MONUMENT FOUND:

I found a  $4"\times4"\times4"$  remains of wood post 10" in the ground with mound of stone on surface.

ACCESSORIES FOUND:

26" dia. Grand Fir with healed blaze and logging scar near blaze bears S8E, 6.2 ft.
No evidence of other BT

Description of monument and accessories I established to perpetuate the original location of this corner:

C. At the position of the pointed post remnant, set a 2.5" dia. by 30" long aluminum pipe with a 2.5" dia. aluminum cap. The pipe is set 10" in the ground with a mound of stone to 2" of the top. The cap is marked:

NEW ACCESSORIES ESTABLISHED

22" dia. Grand Fir bears \$56W, 37.3 ft.; scribed 4 MS 813 PACIFIC BT

Painted the blaze red on each BT Painted a 6" wide red band around each BT

Placed brass washer marked "PLS 2060" at base of each BT blaze

Placed metal sign with bearing and distance information on each BT (54-3)

Placed metal ATTENTION sign on each BT (54-4)

Placed 6 ft. metal guard post at corner with metal FROPERTY BOUNDARY sign and metal ATTENTION sign (54-2 and 54-4)

I measured to the centerline of each bearing tree using tape and hand compass with declination set at 20 degrees east.
