At the locus of distance and reversed bearing from the original bearing tree, set a 2.5" dia. by 30" long aluminum pipe with a 2.5" dia. aluminum cap. The pipe is set 4" in the ground on bedrock with lange mound of earth and stone to 4" of the top.

I measured to the centerline of each bearing tree using tape and hand compass with declination set at 20 degrees east.
