OBT: A wester larch 14" dia brs S51 1/2°E, 26.4' dist per record with partially healed blaze.

A rotten fir root brs N18 1/2°E, 17.0' dist per record.

At position of JRM cap monument is best remaining evidence of original corner...

Removed brass cap monument and replaced with 2" x 30" aluminum pipe with 2 1/2" aluminum cap 25" in ground surrounded with rock mound. Cap marked as shown in corner diagram. Set steel fence post with signs 54-2 & 54-9 attached.

No new bearing trees established. Each bearing tree has a sign 54-3 & 54-9 attached below a 6" band of red paint and a painted blaze.


