A Pine 40 ins diam bears N55'W 1.06 lks dist marked 1/4 S BT A Pine 36 ins diam bears S35'W 88 lks dist marked 1/4 S BT

Description of corner evidence found:

Found no corner evidence. Searched a 200 foot radius around corner area on 3 separate occasions. Corner area has been both burned and logged. Re-establish corner position by single proportionate measurement based on the McCormack record.

Description of monument and accessories I established to perpetuate the original location of this corner:

Set  $2 \frac{1}{2}$ " x 30" aluminum pipe with standard USFS  $3 \frac{1}{4}$ " aluminum cap 24" in the ground surrounded by stone mound. Cap is stamped as shown in corner diagram. Set aluminum fenceposts with 54-9 and 54-2 signs 5' east and 5' west of corner monument.

New bearing trees established:
11" Ponderosa Pine bears S45'W 25.1' distance scribed 1/4 S2 BT.
10" Ponderosa Pine bears S48'E 42.6' distance scribed 1/4 S2 BT.
10" Ponderosa Pine bears N21'E 50.1' distance scribed 1/4 S35 BT.

New bearing object established:

Stone 2.3' W x 1.0' H x 1.6' D bears N86'W 20.1' distance marked B0 +.

New bearing trees have a brass washer stamped PLS 2672 nailed to face of blaze. Attached 54-3 and 54-9signs to each bearing tree and painted face of blaze and a 6" band around each bearing tree. The distance is measured to a 50d nail in side center of bearing trees.
