A pine 20 ins diam bears N 70° E, 95 lks dist marked T 9 S R 37 E S 13 BT A pine 24 ins diam bears S 15° E, 17 lks dist marked T 9 S R 37 E S 24 BT A pine 16 ins diam bears S 7° W, 30 lks dist marked T 9 S R 37 E S 23 BT A fine 24 ins diam bears N 60° W, 76 lks dist marked T 9 S R 37 E S 14 BT

Description of corner evidence found:

Section 24 bearing tree is a highcut sawed stump with visible scribe marks.

Sec 14 and 23 bearing trees are sawed stumps with no visible scribes, lower blaze is evident on sec 14 BT.

No trace of section 13 bearing tree.

Description of monument and accessories I established to perpetuate the

original location of this corner:

At the locus of distance intersections from the above described original accessory evidence set a 2s inch aluminum cap on 2 inch aluminum pipe 31 inches long and projecting out of the ground 5 inches with a surrounding dirt and rook mound. Placed a 6 foot steel fence post alongside with a sign 54-9 attached.

Aluminum cap marked thus;

New bearing trees: A fir 6 ins diam bears N 14° E, 90.6 ft dist marked T 9 S R 37 E S 13 BT A fir 13 ins diam bears N 75° W, 94.1 ft dist marked T 9 S R 37 E S 14 BT A pine 8 ins diam bears S 46° W, 61.9 ft dist marked T 9 S R 37 E S 23 BT A fir 8 ins diam bears S 63° E, 39.5 ft dist marked T 9 S R 37 E S 24 BT

Each new bearing tree has a sign 54-3 attached below a 6 inch band of red paint and has a brass washer marked PLS 1639 nailed flush with BT blaze. A sign 54-9 is attached on the opposite side of tree from BT blaze. The original bearing tree stumps have a 6 inch band of red paint and signs
