## CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment: Corner originally ESTABLISHED by John Hagel, U.S.Deputy Mineral Surveyor, under instructions dated June 30, 1902, for the Amazon Group of Quartz Claims, Mineral Survey No. 480.

Surveyor General records state: To Cor No 4 (of the Brooklyn Lode Identical with the NE cor of the location. Set a white fir post 5 ins square  $4\frac{1}{2}$  ft long 12 ins in ground scribed BRO.C.4-480 with a mound of rocks around it. A white fir tree 14 ins diam bears N76 W, 49.1 ft. A white fir tree 12 ins diam bears N88 W, 49.7 ft, both blazed and scribed BRO.C.4-480 BT.

Corner REMONUMENTED by L.L.Myers, ORLS 699, in 1970 as described in his record filed with the Baker County Surveyor (No. 9-37-18), on Aug 31,1977, which states: "Found the rock mound and two douglas fir bearing trees which have grown to about 24". The 14" BT has been broken off and is now a stub about 6' high. I set a 5/8" x 30" rebar with a 2" aluminum cap marked as shown above in the center of the rock mound for the corner. John Mitchell had placed bearing tree tags on the two BT

## Description of corner evidence found:

A  $1\frac{1}{3}$ " aluminum cap on 5/8" x 30" steel rebar with earthen mound with a 4"x4"x24" wood post alongside mkd COR 4 B on two faces, COR 2 on another face and C/6 on the other face aluminum cap per Baker County Survey No 9-37-18, and marked as shown to right, from which:



OBT: A 30" white fir with fully healed blaze brs N85°W. 50.5' dist (record, N76 W, 49.1' dist).

A 24" white fir wind blown snag 6' long with fragmentary remains of scribing BRO 4 480 BT on partially healed blaze brs N74 $^{\rm O}$ W, 49.4' dist (record, N88 $^{\rm O}$ W, 49.7' dist).

## Description of monument and accessories I established to perpetuate the original location of this corner:

At position of rebar with  $l\frac{1}{2}$ " aluminum cap... Removed rebar monument and replaced with 2" x 30" aluminum pipe with  $2\frac{1}{2}$ " aluminum cap 25" in ground and surrounded with rock mound. Cap marked as shown in corner diagram. Set 6' steel fence post alongside with signs 54-2 and 54-9 attached. Drove rebar below ground surface alongside aluminum

New bearing trees established: A ponderosa pine 11" diam brs S42°E, 39.3' dist mkd B-4-480 BT.

New bearing trees have a brass washer stamped PLS 1639 nailed to face of blaze. Attached signs  $54-3\ \&\ 54-9$  and painted face of blaze and 6" band of red paint around each BT.

Compass declination 20° East.
