
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

Corner 2, Amazon Lode, M.S. 480.

History of original corner establishment:

Corner originally ESTABLISHED by John Hagel under instructions dated June 30, 1902, for the Amazon Group of quartz claims mineral survey No. 480.

Surveyor General records state: To Cor No 2. Identical with the SW cor of the location. Set a black pine post 5 ins square $4\frac{1}{2}$ ft long 18 ins in the ground scribed AMA.C2-480 with a mound of rocks around it. A tamarack tree 24 ins in diam blazed and scribed AMA.C2-480-BT bears S88 05'W, 8.5 ft.



Corner RECOVERED by J.R.Mitchell, experienced corner recovery technician, in October, 1970, and he placed sign 54-3 on OBT.

Description of corner evidence found:

No trace of original corner post or rock mound.

A 24" western larch snag with partially healed blaze mkd AMA C 2 480 BT brs $$88^{\circ}05$ 'W, 8.5' dist per record.

Description of monument and accessories I established to perpetuate the original location of this corner:

At position determined by reversed record bearing and distance from original BT...

Set 2" x 30" aluminum pipe with $2\frac{1}{2}$ " aluminum cap 25" in ground and surrounded with a mound of earth and stone. Cap marked as shown in corner diagram. Set 6' steel fence post alongside with signs 54-2 and 54-9 attached.

New bearing trees established: A lodgepole pine 12" dia brs S49 $^{\rm O}$ E. 33.6' dist mkd A-2-480 BT. A lodgepole pine 16" dia brs N60 $^{\frac{1}{2}}$ E, 51.9' dist mkd A-2-480 BT.

New bearing trees have a brass washer stamped PLS 1639 nailed to face of blaze. Attached signs 54-3 & 54-9 and painted face of blaze and 6" band of red paint around each BT.

Compass declination 20° East.
