

NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF BO ADAMS (AKA WILLIAM ZUNINO) AND SHARON KYLLO. THE PURPOSE OF THIS SURVEY WAS TO DETERMINE THE CORNERS OF THAT CERTAIN PROPERTY DESCRIBED IN DEED NO. B15470063. SAID PROPERTY IS COMPRISED OF LOTS 9 AND 10 OF BLOCK 2 OF SUMPTER HEIGHTS MCEWEN'S ADDITION TOGETHER WITH THAT PORTION OF THE EAST HALF OF THE ADJOINING ALLEY VACATED BY ORDINANCE NO. 1984-8, WHICH INURED THERETO.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. FIELD MEASUREMENTS WERE MADE TO LOCATE APPURTENANT MONUMENTS FROM SURVEY NO.'S 9-37-67 AND 9-37-263. I FOUND ALL FOUR OF HANLEY'S MONUMENTS FROM SURVEY NO. 9-37-67, AND THE MONUMENT AT THE NORTHEAST CORNER OF LOT 5 FROM SURVEY NO. 9-37-263. I ALSO FOUND AN UNRECORDED HANLEY MONUMENT AT THE SOUTHWEST CORNER OF THE SUBJECT PROPERTY. I ACCEPT ALL OF THESE FOUND MONUMENTS. I ALSO FOUND AN UNRECORDED 1/2" IRON PIN S.50°E., 0.3 FT. FROM THE FOUND ACCEPTED HANLEY MONUMENT AT THE NORTHEAST CORNER OF LOT 10. THE 1/2" IRON PIN WAS REPORTEDLY SET BY AN UNLICENSED INDIVIDUAL, AND WAS REMOVED TO AVOID CONFUSION.

I SET A NEW MONUMENT AT THE NORTHWEST CORNER OF THE SUBJECT PROPERTY ACCORDING TO THE EVIDENCE FOUND, AS SHOWN.
