NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO MONUMENT A TRACT OF LAND SITUATED IN NORTHWEST AND THE SOUTHWEST QUARTERS OF SECTION 29, TOWNSHIP 9 SOUTH, RANGE 37 EAST OF THE WILLAMETTE MERIDIAN, CITY OF SUMPTER, COUNTY OF BAKER, STATE OF OREGON, THAT CERTAIN TRACT OF LAND DESCRIBED IN DOCUMENT NUMBER BO7 33 0238, BAKER COUNTY DEED RECORDS.

THE PROJECT BEGAN WITH A SEARCH FOR, AND SURVEY OF EXISTING MONUMENTS CONTROLLING THE SUBJECT PROPERTY AS SHOWN. UTILIZING SAID DEED AND EXISTING EVIDENCE FOUND ON THE GROUND, THE DEED LINES WERE DETERMINED AS FOLLOWS:

THE EAST LINE ALSO BEING THE WEST RIGHT-OF-WAY LINE OF BOURNE AVENUE WAS DEFINED BY HOLDING THE MONUMENT AT THE NORTHEAST CORNER OF LOT 10, BLOCK 3, VINSONS ADDITION TO A LINE 70.00' WESTERLY FROM THE MONUMENT FOUND AT THE SOUTHWEST CORNER OF LOT 39, CRACKER CREEK ESTATES.

THE NORTH AND SOUTH LINES OF BLOCKS 6 AND 11 AND THE SOUTH LINE OF THE ALLEY OF BLOCK 3, OF SAID PLAT, ALSO BEING THE NORTH LINE OF SUBJECT PROPERTY WERE ESTABLISHED BY HOLDING THE MONUMENT AT THE NORTHEAST CORNER OF LOT 10 BLOCK 3 AND TURNING A RIGHT ANGLE FROM SAID EAST LINE HOLDING PLAT DISTANCES ALONG SAID EAST LINE FOR STREETS, ALLEYS AND LOTS AND CONFIRMED BY THE MONUMENT FOUND NEAR THE SOUTHEAST CORNER OF BLOCK 11 OF SAID PLAT.

THE WEST LINE ALSO BEING THE EAST LINE OF THE GOLD WEDGE PLACER MINE WAS ESTABLISHED BY HOLDING THE MONUMENTS AT POINT A, B AND OTHER MONUMENTS SHOWN ALONG SAID EAST LINE AND THE DISTANCES FROM SN 09-37-0293 AS SHOWN.
