A fir snag 44 ins dia broken at 15' with full scribes on open blaze, brs $S41^*W$ 6.6 ft. No trace of the other BT.

Set 2 1/2 in aluminum cap on 2 in aluminum pipe 30 ins long 25 ins in ground with 5 ins proj. out of ground with rock mound and 6 ft steel fence post alongside with sign 54-9 attached.

Aluminum cap marked as shown in corner diagram.

New bearing trees established:

A fir 12 ins dia bears S86°30'W 9.1 ft marked BB5-452 BT. A fir 9 ins dia bears N31°45'W 25.7 ft. marked BB5-452 BT.

Each original bearing tree and each new bearing tree has signs 54-3 and 54-9 attached below a 6 in band of red paint, additionally each new bearing tree has a brass washer marked PLS 1639 nailed flush with BT blaze.


