A tamarack 10 ins dia bears S33°05'W 21.90 ft, a tamarack 10 ins dia bears N88°20'E 19.04 ft, both blazed and scribed 2-679-K BT.

Corner was remonumented by: William L. Hanley, per Corner Record 9-37-101; dated March 14, 1986.

Found remains of original pine post.

A tamarack stump with full scribes sawed off above scribes brs S33°W, 21.9 ft. A tamarack 14 ins dia with full scribes on an open blaze brs N88°20E, 19.04 ft

Set a 2 1/2" aluminum cap on 2" aluminum pipe 30 ins long 25 ins in ground with 5 ins proj. out of ground with surrounding rock mound and 6 ft steel fence post alongside with sign 54-9 attached. Buried remains of original post alongside.

Aluminum cap marked as shown in corner diagram.

New bearing tree established: A pine 6 ins dia bears N15°E 24.6 ft marked K-2-679 BT.

Each original bearing tree and each new bearing tree has signs 54-3 and 54-9 attached below a 6 inch band of red paint, additionally each new bearing tree has a brass washer marked PLS 1639 nailed flush with BT blaze.

An 8 inch pine snag (by Hanley) with partially healed blaze and visible scribe marks, bears N15°E, 24.6 feet.


