Set 2"  $\times$  30" aluminum pipe with 2 1/2" aluminum cap 25" in ground and surrounded with a mound of earth & stone. Cap marked as shown in corner diagram. Set 6' steel fence post alongside, and attached signs 54-9 & 54-2.

New bearing trees established:

A lodgepole pine 6" dia brs S29 1/2°E, 12.3' dist mkd BS-3-745 BT. A lodgepole pine 8" dia brs N76'W, 30.5' dist mkd BS-3-745 BT.

New bearing trees have a brass washer marked PLS 1639 nailed to face of blaze. Attached signs 54-3 & 54-9 and painted face of blaze and 6" band of red paint around each bearing tree.

Compass declination 20° East.
