CERTIFIED RECORD OF LAND CORNER MONUMENTATION

Description of corner evidence found:

A 2 1/2 galvanized iron pipe with a 3 1/4 inch BLM brass cap, marked as shown. Firmly set 3 inches above ground, with a rock collar.

From which:

A 19 inch fir stump (by GLO) bears S82°E, 7.3 feet.

NW BT (by GLO) not found.

An 11 inch western larch (by BLM) with healed blaze, bears N70°W, 47.9 feet to spike in left side of tree center, alive and healthy.

A 19 inch western larch cut stump (by BLM) bears S61°E, 167 links.

An 8 inch lodgepole pine (by Fox) without blaze, bears N50°E, 8.9 feet to spike in left side of tree center.
