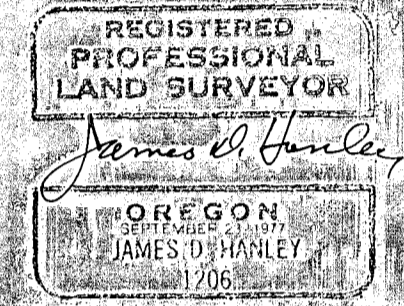


PARTITION PLAT NO.
SURVEYOR'S CERTIFICATE

James D. Hanley certify that I have correctly surveyed parcel No. 1 and platted parcels No. 1 and No. 2 of the land on the annexed partition map in accordance with O.R.S. Chapter 92. The boundary of the partition is as follows:
A parcel of land in the SW 1/4 and the S 1/2 N 1/2 of Section 1, Township 9 South, Range 40 East, Willamette Meridian.
Beginning at the South quarter corner of Section 1; thence S. 89° 56' 58" W. along the South line of said Section 1 1017.20 feet; thence N. 0° 00' 13" E. 2006.21 feet; thence West 24.3 feet to the Southeastly right of way line of O.S.H.D. Hwy. 86; thence Northerly and Easterly along the said right of way line approximately 4500 feet to the East line of the said section; thence S. 0° 07' 05" E. along the said East line approximately 370 feet to the East quarter corner of said section 1; thence S. 89° 10' 58" W. along the South line of the said N 1/2 2675.58 feet to the center quarter corner of said section 1; thence along the East line of the SW 1/4 2667.12 feet to the point of beginning, excepting therefrom Baker County road.

NARRATIVE

The purpose of this plat for John and Margaret Bootsma is to partition the land described in Baker County Deed No. 92-28-042 into two parcels as shown. Survey data from Baker County Surveys 9-40-6B, 9-40-49, 9-40-305 and O.S.H.D. drawing No. 6B-6-15 was utilized for the preparation of this plat. Field survey measurements were made along the South and East lines of the Southwest quarter Section 1. Bearings from Survey No. 9-40-49 are rotated 1° 52' 01" clockwise to conform to Surveys 9-40-6B and 9-40-305. Richland Hwy. No. 86 centerline road data shown is from O.S.H.D. Drawing No. 6B-6-15, not resurveyed for this partition plat. Partition was surveyed July 13, and Oct. 16, 1992.

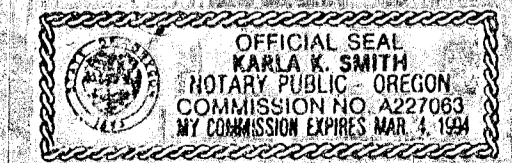
