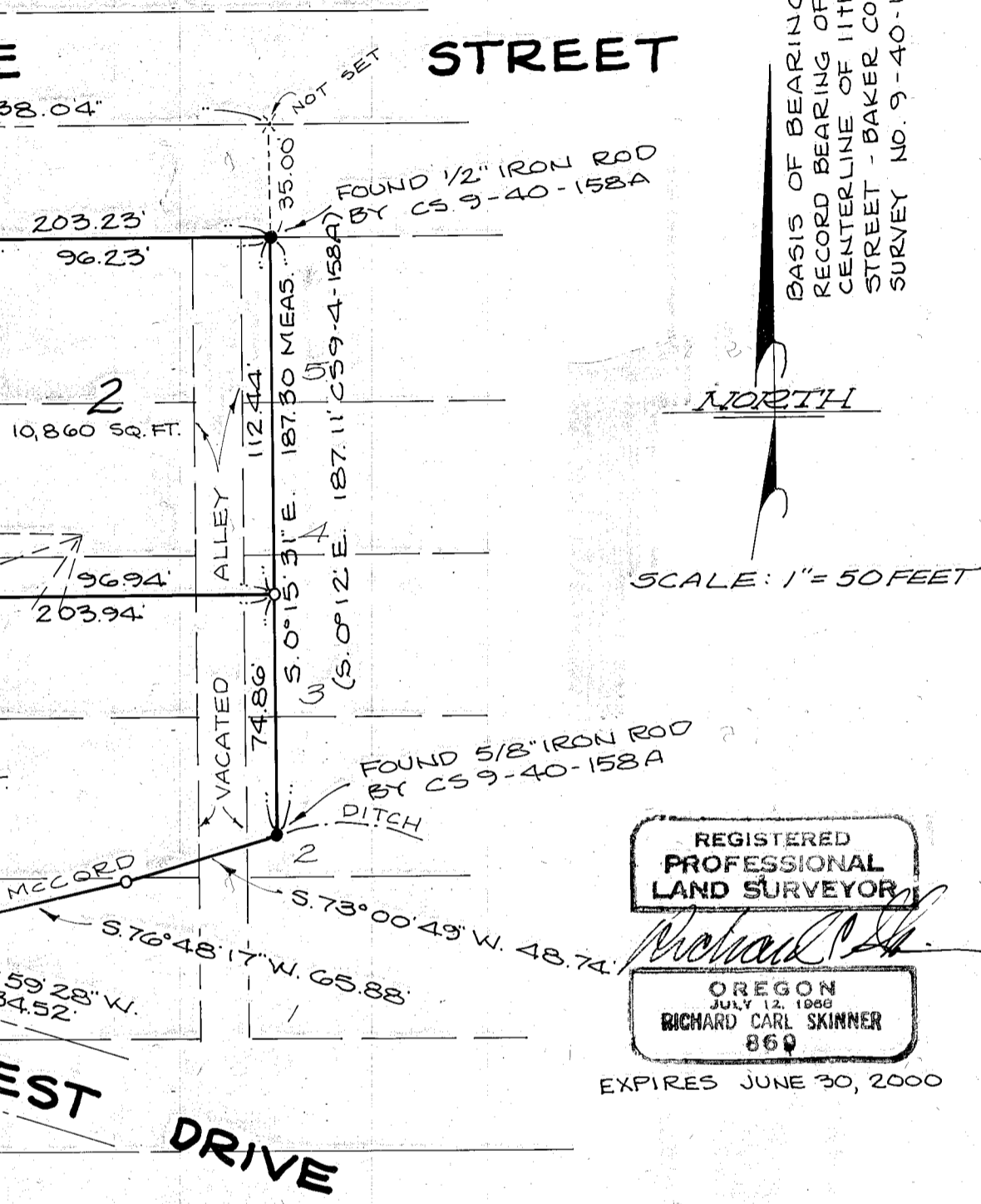

SURVEYOR'S CERTIFICATE

I, RICHARD C. SKINNER, A REGISTERED PROFESSIONAL LAND SURVEYOR IN THE STATE OF OREGON, DO HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED THE LAND DESCRIBED HEREON, LOCATED IN THE NORTHWEST QUARTER, OF SECTION 20, TOWNSHIP 9 SOUTH, RANGE 40 EAST OF THE WILLAMETTE MERIDIAN, IN ACCORDANCE WITH O.R.S. CHAPTER 92; THAT THE INITIAL POINT IS A 5/8" DIAM. IRON ROD, 30" LONG, WITH A 1 1/2" DIAM. ALUMINUM CAP MARKED "R. SKINNER PLS 869" AND THAT THE EXTERIOR BOUNDARY LINES OF SAID LAND IS DESCRIBED AS FOLLOWS:

IRON ROD; THENCE ALONG THE SOUTH RIGHT-OF-WAY LINE OF MYRTLE STREET NORTH 89°47'49" EAST 203.23 FEET TO A 1/2" DIAM. IRON ROD; THENCE SOUTHERLY ALONG A LINE WHICH IS WESTERLY 177.00 FEET AND PARALLEL WITH THE WEST RIGHT-OF-WAY LINE OF THE VACATED 10TH STREET AS DETERMINED IN COUNTY SURVEY 9-40-158A, SOUTH 0°15'31" EAST 187.30 FEET TO A 5/8" DIAM. 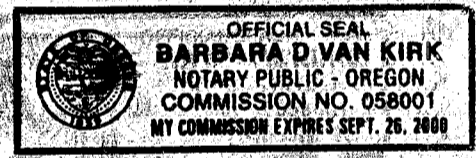

THE PURPOSE OF THIS SURVEY IS TO REPLAT PORTIONS OF LOTS 2, 3, 4, 5, 8, 9 AND 10, AND LOTS 6 AND 7, BLOCK 45, REVISED McCRARY'S ADDITION TO BAKER CITY.

THE NORTH BOUNDARY IS A LINE SOUTHERLY 35.00 FEET AND PARALLEL TO THE CENTERLINE OF MYRTLE STREET. THE EAST BOUNDARY IS A LINE ESTABLISHED IN BAKER COUNTY SURVEY NO. 9-40-158A.
