NARRATIVE

The purpose of this partition plat is to divide Parcel 3, Partition No. 1999-012 in the NW1/4NE1/4 of Section 29, T9S, R40E, WM, City of Baker City, Baker County, Oregon into two parcels at the request of Sterlin D. Owens.

This parcel was surveyed in 1999 by Timothy Rouse, PLS 2799 during Baker County Survey No. 9-40-503 or Partition No. P1999-012 and I found all the monuments used by him. I found several of Tim's distances and bearings between monuments as much as a foot and a half different than what shows on his plat. Three sides of the Owens property is controlled by street and highway right-of-ways and regardless of where the monuments fall the boundary is on the right-of-way line. The monuments do control the position of the dividing property lines.

No new monuments were set by this survey as all the necessary pins had been set apparently during an unrecorded survey, but documented on the partition plat recorded as Survey No. 9-40-503. This plat simply connects two previously set pins to divide the parcel into two.

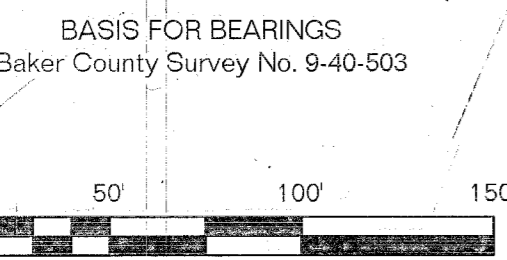
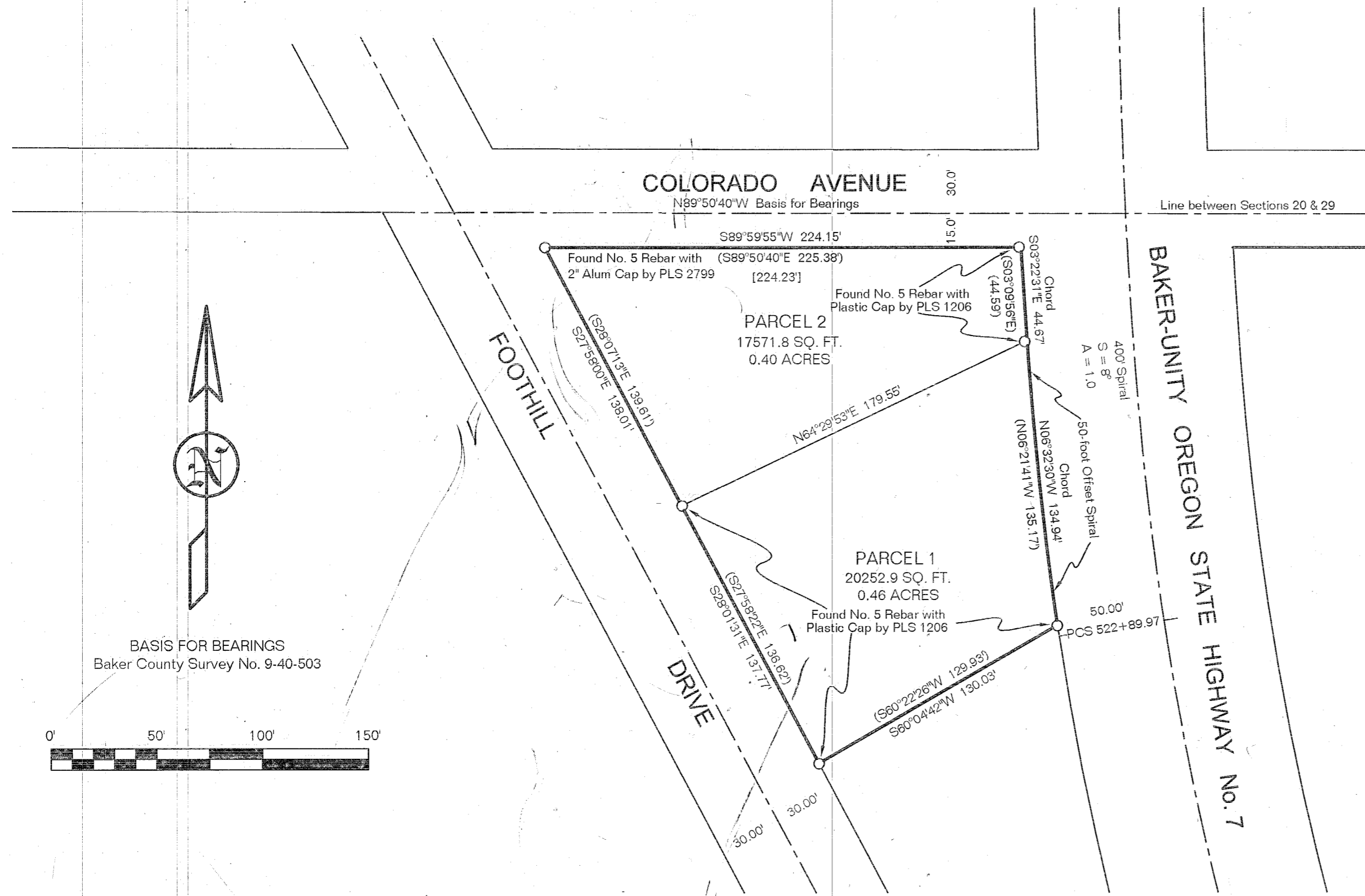
