NARRATIVE

THE PURPOSE OF THIS SURVEY FOR NELSON CLARKE AND BRAD ALLEN IS TO MARK UPON THE GROUND WITH PROPER MONUMENTATION THE NEW LINE OF A PROPERTY LINE ADJUSTMENT BETWEEN TRACT ONE (BAKER CITY DEED NO. BO4 15 0362) AND TRACT 2 (BAKER CITY DEED NO. 99-50-136). EAST-WEST PROPERTY LINE IS ADJUSTED SOUTHERLY TO THE SOUTH LINE OF LOT 16 OF BLOCK 17 OF FAULL'S

SEARCH IN THE FIELD LOCATED EXISTING MONUMENTATION ACCORDING TO SURVEY NO. 9-40-104 BC. THE MONUMENT 120.60 FEET SOUTH OF THE NORTHEAST CORNER OF SAID BLOCK 17 WAS FOUND 2.60 FEET FROM RECORD POSITION APPARENTLY DISTURBED, THIS MONUMENT WAS REJECTED AND BEARING AND DISTANCE TO RECORD POSITION IS STATED ON THIS SURVEY. 
