NARRATIVE

HANLEY ENGINEERING, INC. WAS EMPLOYED BY ERNEST E. SMITH TO COMPLETE THE SURVEY AND MAPPING REQUIREMENTS OF THIS PARTITION OF PARCEL 1 OF PARTITION PLAT NO. 2007-018.

SEARCH IN THE FIELD REVEALED EXISTING CENTERLINE MONUMENTS OF THE PUBLIC USAGE ROAD AS PER SURVEY NO. 9-40-322. DEED NO. 74-15-066 DESCRIBES LAND BY CARDINAL DIRECTIONS, WHICH WE INTERPRETED AS PARALLEL TO SECTION GEOMETRY. WE HELD RECORD BEARINGS AND DISTANCES OF SURVEY NO. 9-40-322.

SEARCH IN THE FIELD ALSO REVEALED EXISTING MONUMENTS AS PER SURVEY NO. 9-40-641MP, WHICH WE HELD TO DEFINE THE WEST LINE OF THIS PARTITION. CORNERS OF SUBJECT PROPERTY WERE LOCATED ACCORDING TO DEED DESCRIPTION AND MONUMENTS WERE SET AS PER CLIENT'S INSTRUCTIONS. SURVEY WAS PERFORMED USING A PENTAX III-10 TOTAL STATION.

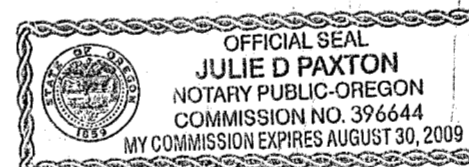
