NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF ROB ELLINGSON, ON BEHALF OF ELLINGSON LUMBER COMPANY. THE PURPOSE OF THIS SURVEY WAS TO REPLAT THE ORIGINAL LOTS FROM STEWART'S SECOND ADDITION TO BAKER CITY INTO THREE NEW LOTS.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. FIELD MEASUREMENTS WERE MADE TO LOCATE EXISTING MONUMENTS SHOWN ON BAKER COUNTY RECORD SURVEY NO. 9-40-479, AND RECORD LAND PARTITION PLAT NO.'S 1990-009 AND 1998-013. I ACCEPT THE FOUND CONTROLLING MONUMENTS, AS SHOWN HEREON.

NEW MONUMENTS WERE SET IN ACCORDANCE WITH THE EVIDENCE FOUND AND AT LOCATIONS APPROVED BY MR. ELLINGSON, AS SHOWN HEREON.
