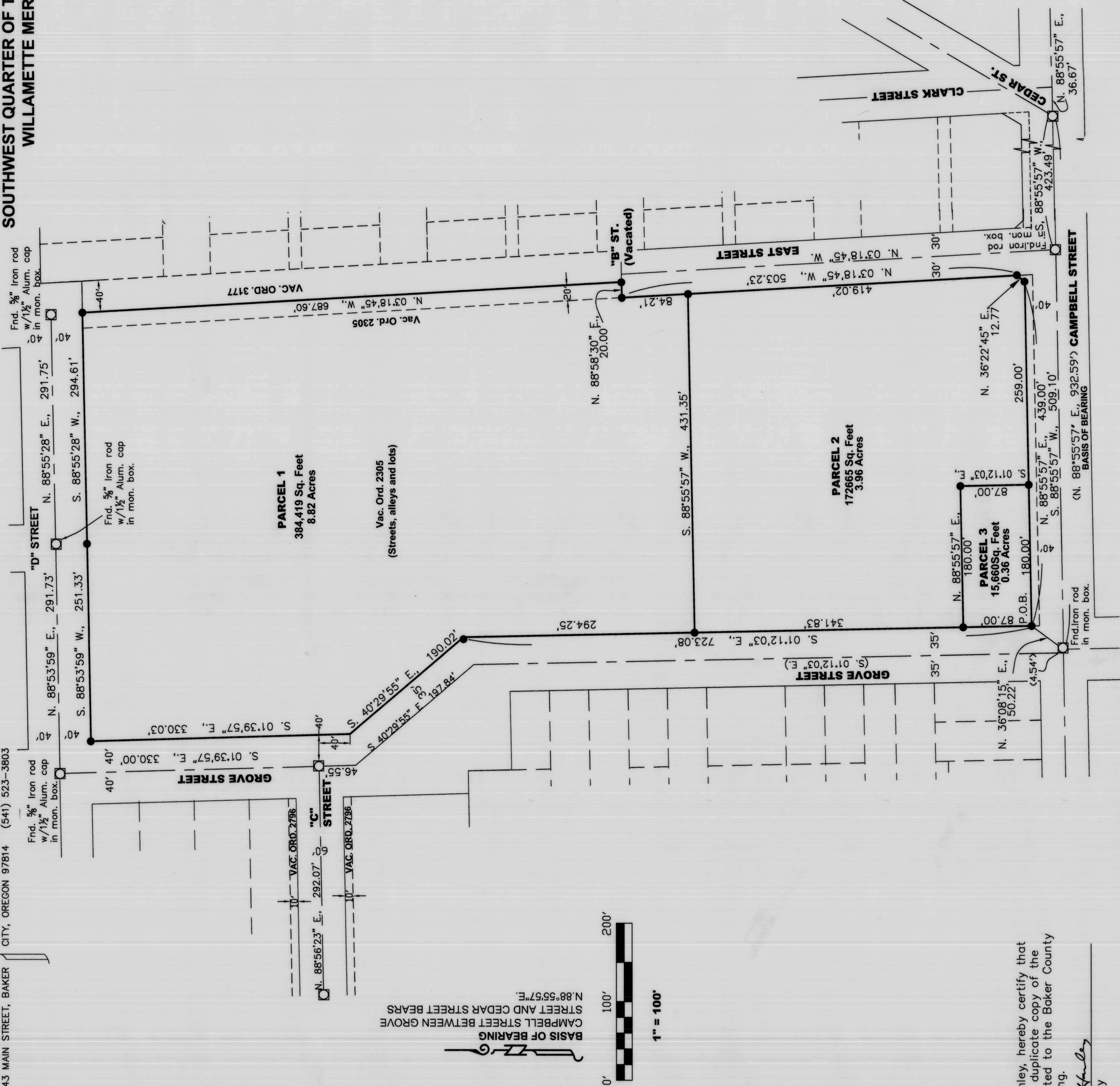

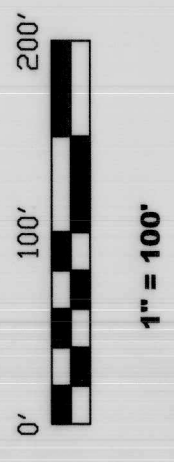

SURVEYOR'S CERTIFICATE

I, Thomas J. Hanley, certify that I have correctly surveyed and platted three parcels of land on this partition plat in accordance with O.R.S. Chapter 92. The boundary of the partition is as follows:

Commencing at the intersection of South Grove Street & Campbell Street; thence N. 36°08'15" E., a distance of 50.22 feet to the intersection of the East right of way of Grove Street & the North right of way of Campbell Street, the Point of Beginning; thence N. 88°55'57" E., along the North right of way of Campbell Street, a distance of 439.00 feet; thence N. 36°22'45" E., a distance of 12.77 feet to a point on the West right of way of East Street; thence N. 03°18'45" W., along said right of way, a distance of 503.23 feet; thence N. 88°58'30"E. along the centerline of vacated "B" Street a distance of 20.00 feet; thence N. 03° 18'45" W. a distance of 687.60 feet to a point on the South right of way line of "D" Street; thence S. 88°55'28" W., along said right of way, a distance of 294.61 feet; thence S. 88°53'59" W., along said right of way, a distance of 251.33 feet to the intersection of the South right of way line of "D" Street and the East right of way line of Grove Street; thence S. 01°39'57" E., along said East right of way, a distance of 330.03 feet; thence S.40°29'55" E., along said right of way, a distance of 190.02 feet; thence S. 01°12'03" E., a distance of 723.08 feet to the Point of Beginning.

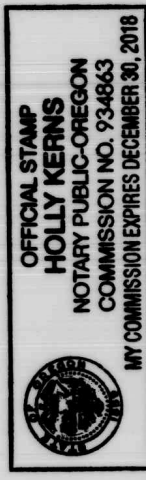

NARRATIVE

The purpose of this survey and plat for Baker County is to survey and partition the above described land into three parcels. Monumentation described in Baker County Survey No. 9-40-682 was recovered; Baker County Deeds Book 168, Page 639, Book 150, Page 283, 82 38 083 and Baker County Deed No. 01 21 0207 provided the property descriptions for the subject property.

A search was made of the available deed and survey records. The property is described by the following documents: Baker County Deed Book 168, Page 639 (Vacation Ordinance 2305) recorded on August 1, 1950 excepting Baker County Deed No. 82 38 083. Baker County Deed Book 150 Page 283 and Baker County Deed Number 01 21 0207 (Vacation Ordinance No 3177).

Baker County Survey 9-40-258C provided the Bearing of Campbell Street. Baker County Survey 9-40-682 was performed by O.D.O.T. while under contract with the City of Baker City to replace monuments of record that were obliterated during construction of the "D" Street improvement project. The controlling monuments for the centerline of "D" Street between Grove and East Street provided the basis for the North line of the partition.

"C" Street was located via Baker City monuments located at the centerline intersections of "C" Street and Walnut Street and "C" Street and Grove Street. The Southerly Right of Way line of the original 80 foot wide Right of Way of "C" Street was projected 40 feet to locate the Northwest Corner of Lot 4, Block 24 of Mix's Addition. Extending the East Right of Way line of Grove Street to the North line of Lot 8, Block 24 of Mix's Addition determined the Northeast line of the parcel described in Baker County Deed No. 82 38 083.

The North 687.60 feet of the East boundary of the partition was determined via Baker County Deed No. 01 21 0207 (Vacation Ord. No. 3177).
