

NARRATIVE

THIS REPLAT WAS PERFORMED AT THE REQUEST OF ANDY BARR, WITH THE PURPOSE OF RECONFIGURING LOTS 8 THROUGH 15 IN BLOCK 5 OF J.P. ATWOOD'S THIRD ADDITION INTO TWO NEW LOTS.

J.P. ATWOOD'S THIRD ADDITION WAS PLATTED IN 1882 BY C.M. FOSTER. THE NORTH 10 FEET OF LOTS 10 THROUGH 14 OF BLOCK 5 WAS CONVEYED TO THE CITY FOR ADDITIONAL RIGHT OF WAY ON CAMPBELL STREET BY DEED NO.'S 71-13-021 AND 71-13-022. TWO TRIANGULAR PORTIONS OF LOTS 10 AND 14 OF BLOCK 5 WERE CONVEYED TO O.D.O.T. FOR RIGHT OF WAY IN DEED NO. B06030027.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS. FIELD MEASUREMENTS WERE MADE TO LOCATE CITY MONUMENTS AT STREET CENTERLINE INTERSECTIONS, AS WELL AS MONUMENTS FROM SURVEY NO.'S 9-40-204, 9-40-461 AND 9-40-755. I SEARCHED FOR, BUT FOUND NO TRACE OF THE MONUMENT SET DURING SURVEY NO. 9-40-461 AT THE SOUTHWEST CORNER OF LOT 8.

DURING THE COURSE OF THIS SURVEY, IT WAS NOTED THAT ALTHOUGH THE EAVES OF A BUILDING ENCRUSH OVER THE NORTH LINE OF LOT 16, THE BUILDING ITSELF DOES NOT. I ACCEPT ALL THE MONUMENTS FOUND DURING THE COURSE OF THIS SURVEY, AND SET NEW MONUMENTS IN ACCORDANCE WITH THE EVIDENCE FOUND, AS SHOWN.

SURVEYOR'S CERTIFICATE

I, JASON L. HATFIELD, PROFESSIONAL LAND SURVEYOR, REGISTERED IN THE STATE OF OREGON, HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED LOTS 19 AND 20 OF THIS REPLAT, BEING SITUATED IN THE NE1/4SW1/4 SECTION 16, T.9S., R.40E., W.M., BAKER CITY, BAKER COUNTY, OREGON, DESCRIBED AS FOLLOWS:

LOTS 8, 9, 10, 11, 12, 13, 14 AND 15, BLOCK 5, J.P. ATWOOD'S THIRD ADDITION, ACCORDING TO THE OFFICIAL PLAT THEREOF.

EXCEPTING THEREFROM THE NORTH 10 FEET OF EACH OF SAID LOTS 10, 11, 12, 13 AND 14.

ALSO EXCEPTING THEREFROM ALL THAT PORTION OF THE ABOVE DESCRIBED LAND CONVEYED TO THE STATE OF OREGON, BY AND THROUGH ITS DEPARTMENT OF TRANSPORTATION, BY INSTRUMENT RECORDED JANUARY 23, 2006, IN BOOK 06 03 0027, RECORDS OF BAKER COUNTY, OREGON.

THIS REPLAT CONTAINS 41,193 SQUARE FEET.

I DO HEREBY DESIGNATE THE SOUTHWEST CORNER OF LOT 19 AS THE INITIAL POINT OF THIS REPLAT.

SUBJECT TO THE FOLLOWING:

- RIGHTS OF THE PUBLIC IN AND TO ANY PORTION OF THE HEREIN DESCRIBED PREMISES LYING WITHIN THE BOUNDARIES OF STREETS, ROADS OR HIGHWAYS.

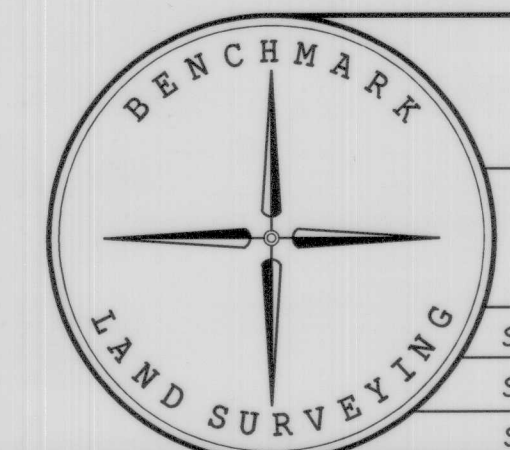
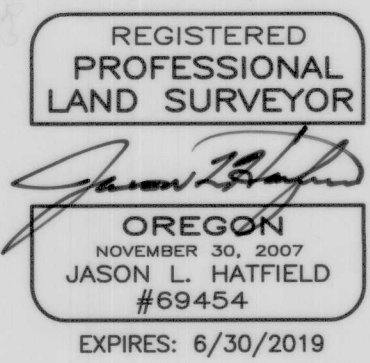
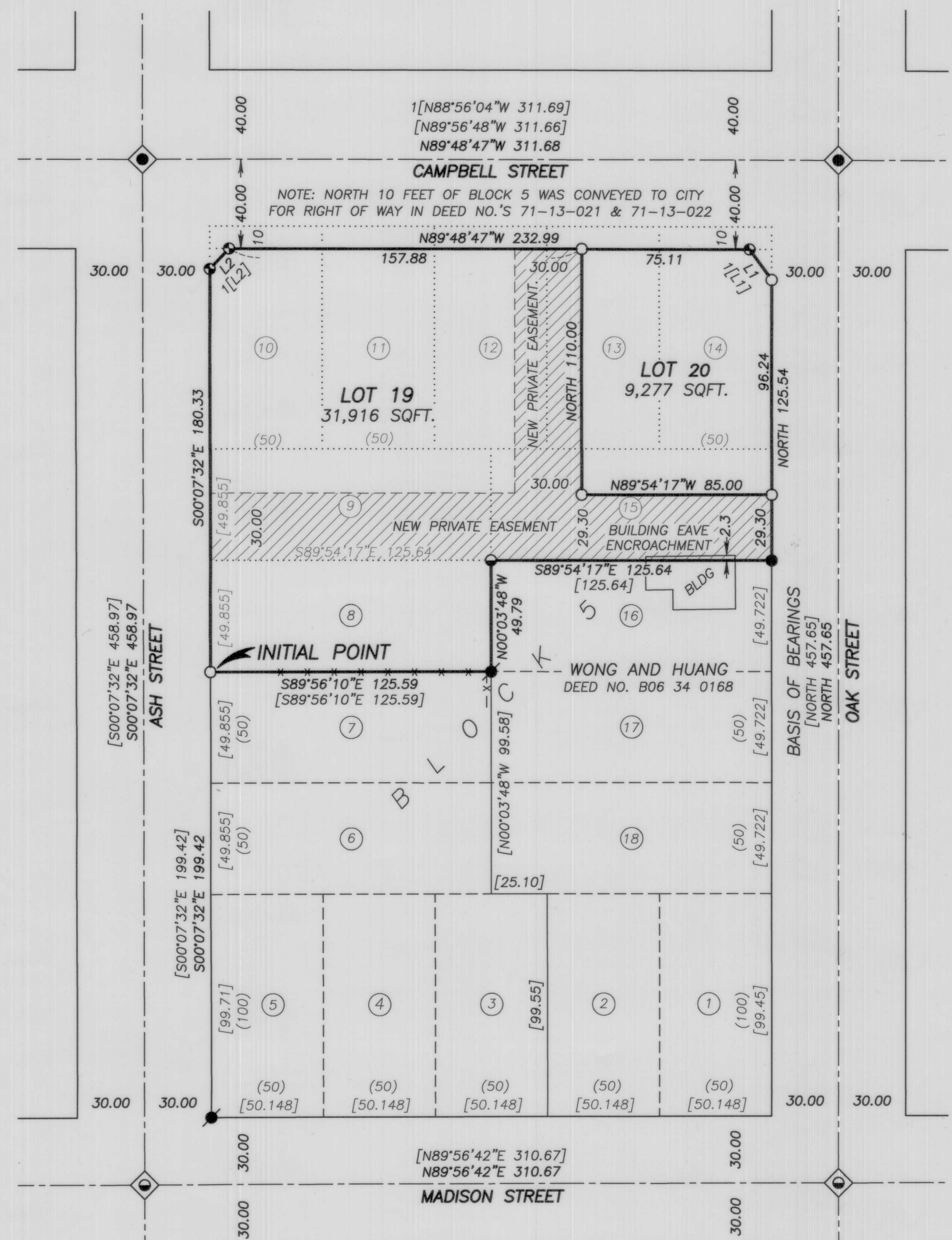
