## *NARRATIVE*

This survey was done at the request of Michael Porter, on behalf of Albertsons. Mr. Porter wanted the exteriors of the property monumented. Lots within this area were originally created by deed, recorded as B02 25 0286 and rerecorded as B02 26 0156, where they are noted as being numbered parcels of Baker Towne Square. They are all metes and bounds descriptions, based on centerlines of Section 16. I rotate the legal descriptions to the East/West running center of section line to place this parcel. It is harmonious with the monuments of Survey 9-40-807 as well as other unrecorded monuments in the area. The corners of the building fall 0.8 ft West of the property line. I find no unusual conditions with this survey.
