NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO MONUMENT A TRACT OF LAND SITUATED IN SOUTHEAST QUARTER OF SECTION 28, TOWNSHIP 9 SOUTH, RANGE 40 EAST OF THE WILLAMETTE MERIDIAN, CITY OF BAKER CITY, COUNTY OF BAKER, STATE OF OREGON, THAT CERTAIN TRACT OF LAND DESCRIBED IN DOCUMENT NUMBER B24500282, BAKER COUNTY DEED RECORDS.

THE PROJECT BEGAN WITH A SEARCH FOR, AND SURVEY OF EXISTING MONUMENTS CONTROLLING THE SUBJECT PROPERTY AS SHOWN. UTILIZING SAID DEED AND EXISTING EVIDENCE FOUND ON THE GROUND, THE DEED LINES WERE DETERMINED AS FOLLOWS:

THE WEST LINE BEING THE EASTERLY RIGHT OF WAY OF OLD HIGHWAY 30, WAS DEFINED BY AS-TRAVELED CENTERLINE THEN OFF-SET 30.00' NORTHEASTERLY.

THE NORTH LINE WAS ESTABLISHED HOLDING A RIGHT ANGLE AND A PRORATED DISTANCE (150.10') FROM STATION 2256+00 TO STATION 2266+19.46.

THE **NORTHERN EAST LINE** WAS ESTABLISHED BY HOLDING 545.00' RIGHT OF THE CENTERLINE OF INTERSTATE 84 AT PRORATED STATION 2257+50.10 AT THE NORTH END

THE **SOUTHERN EAST LINE** WAS ESTABLISHED BY HOLDING THE SOUTHEAST CORNER OF SAID SECTION 28 AND THE CALCULATED EAST QUARTER CORNER OF SAID SECTION 28 PER SN 9-40-588 (S5).

THE **SOUTH LINE** WAS COMPUTED PER THE 2009 BLM MANUAL OF SURVEYING AND INSTRUCTIONSAS SHOWN. THEN MONUMENTS WERE SET AS SHOWN.
