A SEARCH WAS MADE OF THE AVAILABLE RECORDS. MR. STILL ACQUIRED TITLE TO THE SUBJECT PROPERTY PER DEED NO. B19200002. THE SUBJECT PROPERTY IS A PORTION OF LOT 2, BLOCK 2 OF J.J. CAMPBELL'S ADDITION (A.K.A. G.W. CAMPBELL'S ADDITION), THE PLAT OF WHICH WAS RECORDED DECEMBER 26, 1887 IN BOOK "M" PAGE 214, DEED RECORDS OF BAKER COUNTY, OREGON.

FIELD MEASUREMENTS WERE MADE TO RECOVER CONTROLLING MONUMENTS SHOWN ON SURVEY NO.'S 9-40-130BC, 9-40-380, 9-40-657, 9-40-682 AND 9-40-802, AND ON PARTITION PLAT NO'S P1995-027 AND P1999-011. I FOUND THE 5/8" REBAR FROM SURVEY NO. 9-40-657 NEAR THE NORTHWEST CORNER OF THE PROPERTY DESCRIBED IN DEED NO. B19420085 DISTURBED BY FENCE CONSTRUCTION. THE PIN WAS FOUND OUT OF POSITION BY THE AMOUNT NOTED HEREON AND WAS NOT ACCEPTED. ALL OTHER FOUND CONTROLLING MONUMENTS WERE ACCEPTED.


