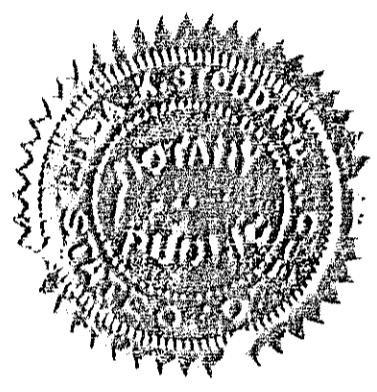


SURVEYOR'S STATEMENT

I, James D. Hanley, being first duly sworn, say that I have correctly surveyed and platted the land represented on the accompanying map of PHASE TWO MATHESON SUBDIVISION, the exterior boundaries of which are described as follows:

Beginning at the Initial Point of this survey, marked by a galvanized, two inches diameter, thirty-six inches long iron pipe, set six inches below the ground surface, at a point which is 115 feet South and 490.16 feet West of the North-east corner of Lot 1, Usher's South Addition (Deed 77-18-082), the said iron pipe further described as being N. 50° 04' 57" W., 685.79 feet from the South-east corner of the NW 1/4 SE 1/4 of Sec. 23, T. 9 S., R. 43 E., W.M.; thence N. 83° 53' 15" W., 115.50 feet; thence S. 0° 08' 15" W., 120.00 feet; thence N. 83° 53' 15" W., 73.0 feet to a point on the West line of that parcel described in Deed 75-47-003; thence S. 0° 08' 15" W., 313.38 feet to the Southwest corner of the said parcel; thence S. 89° 56' 32" E., 194.50 feet to the Southwest corner of Lot 5, Matheson Sub-division; thence N. 0° 08' 15" E., 433.53 feet to the point of beginning.



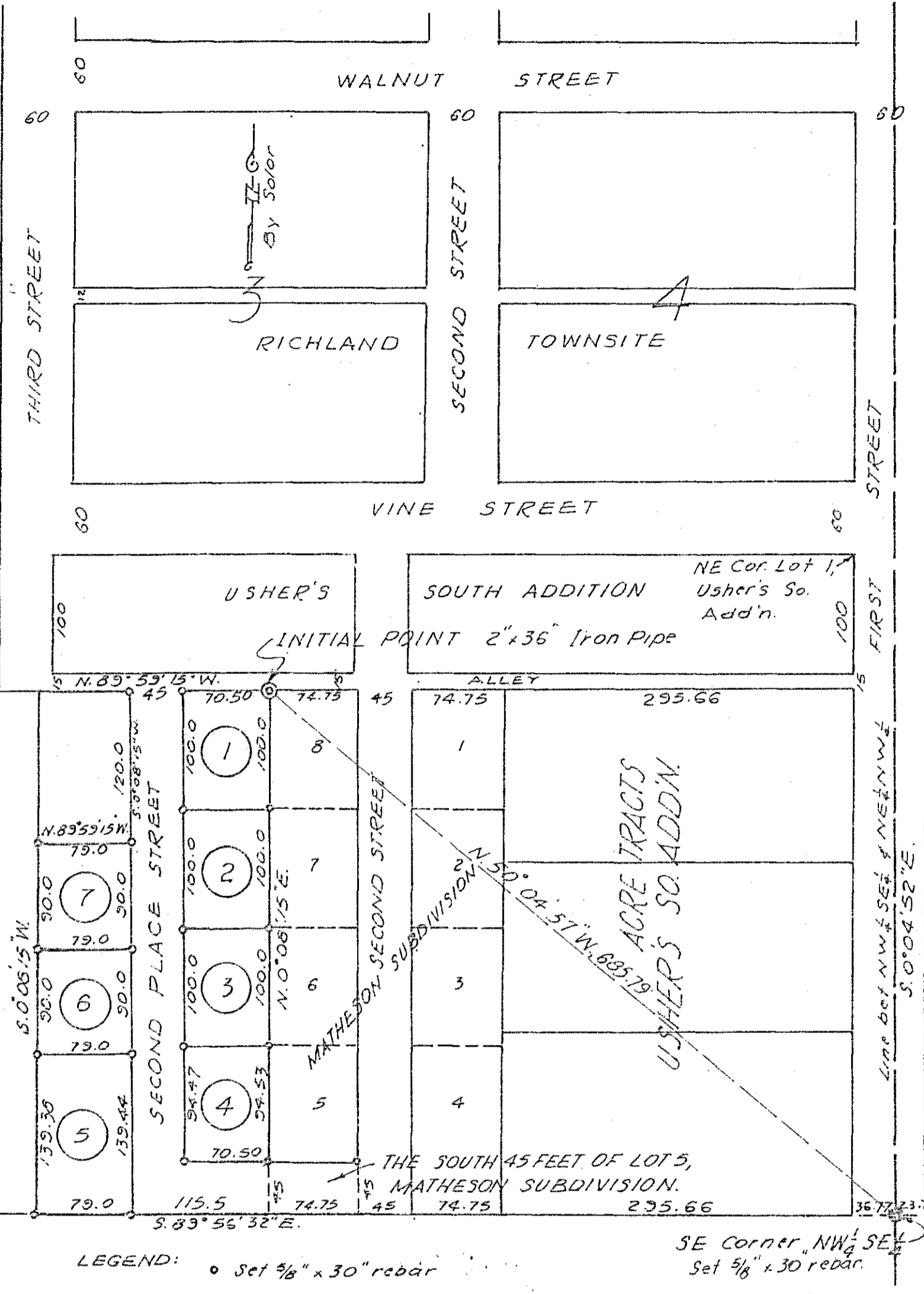
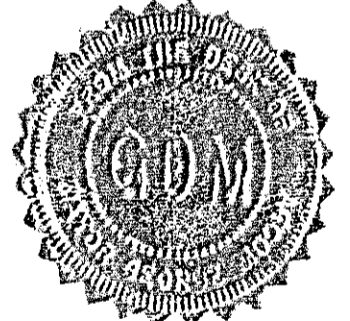

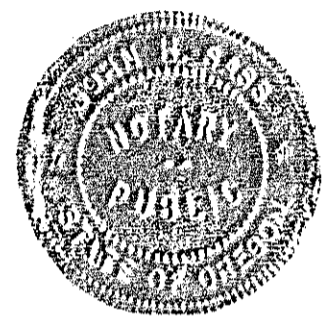
