I, James D. Hanley, hereby certify that I have correctly surveyed and platted the land represented on the annexed minor partition map, in accordance with O.R.S. Chapter 92. The exterior boundary is described as follows: A tract of land in the Northeast Quarter of the Southwest Quarter of Section 10, Township 9 South, Range 45 East, Willamette Meridian, County of Baker, State of Oregon, more particularly described as follows:

Beginning on the Easterly right of way line of Baker County Road No. 975 at a point which bears N. 89° 49' 08" E., 30 feet from the Southwest corner of the 1/2 NE 1/4 SW 1/4 of Section 10, T. 9 S. R. 45 E., W.M., and being N. 45° 23' 28" E., 1878.46 feet from the Southwest corner of the said section; thence N. 0° 21' 05" W., 658.93 feet along said right of way line; thence N. 89° 45' 25" E., 1011.0 feet to the centerline of Eagle Creek channel; thence following said channel centerline: S. 02° 03' 25" W., 214.56 feet, S. 07° 55' 53" W., 222.12 feet, and S. 0° 21' 20" E.; 225.73 feet to the South line of the said NE 1/4 SW 1/4; thence S. 89° 49' 08" W., 970.0 feet along said South line to the point of beginning.
