

THE PURPOSE OF THIS SURVEY IS TO DEFINE PARCEL 1, PARTITION PLAT NO. 1994-012, RECORDED AUGUST 11, 1994 IN INSTRUMENT NO. 94 32 144, BAKER COUNTY RECORDS, SITUATED IN THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION 22, TOWNSHIP 9 SOUTH, RANGE 45 EAST, WILLAMETTE MERIDIAN, BAKER COUNTY, OREGON, AND TO REPLAT SAID PARCEL INTO 2 NEW PARCELS, AT THE REQUEST OF CALVIN RANSOM.
