History of original corner establishment:

Corner was originally established by Herman D. Gradon under G.L.O. contract No 416 during October, 1881. Surveyor General's notes state: "Set a basalt stone 20x12x5 ins. 15 ins. in the ground for cor. to secs. 15, 16, 21, and 22, marked with 3 notches on S and E edges: From which, A pine 12 ins. diam. bears N20°E 55 lks. dist. marked TloSR35ES15 BT. A pine 30 ins. diam. bears S30°E, 34 lks. dist. marked TloSR35ES22 BT.

A pine 24 ins. diam. bears S45°W, 26 lks. dist. marked TloSR35ES21 BT. A pine 36 ins. diam. bears N17°W, 45 lks. dist. marked TloSR35ES16 BT."

Description of corner evidence found:

Found 20x16x4 inch stone in small nound of stone, firmly set and marked with 3 notches on S and E sides, from which a 34" pine bears S28°E, 24.7 ft. with partially grown over blaze and visible scribing. Other BTs down and rotten.

Description of monument and accessories I established to perpetuate the original location of this corner:

At the center of the above stone, set 2 1/2" X 30"

galvanized pipe and brass cap marked: Set pipe 20" in 1980

the ground and mound of stone around to cap.

From which by magnetic declination of N20°E: A 32" pine bears N39°E, 111.7 ft. scribed T10S R35ES15 BT. A 22" pine bears S23°W, 50.1 ft. scribed T10SR35ES21 BT. A 14" Fir bears N79°W, 89.8 ft. scribed T10SR35ES16 BT. Painted blazes red and 6" red band around. Placed 54-3s, 54-4s and brass washers stamped PLS 1051 on BTs. Placed 54-4 on steel fence post 5' West of the corner.
