CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner was originally established by Ira. L. Hoffman under Mineral Survey 552 during September 1903. The original notes state that at the corner a 4' long x 6" square marked pine post was set 18" in the ground and surrounded with a mound of earth and stone from which:

A 6" pine bears N63°W-19.1' marked Ophir-8-552-BT. A 6" pine bears S55°40'W-21.7' marked Ophir-8-552-BT.

Description of corner evidence found:

The remains of a rotted post in a mound of stone from which;

A 10" dead 1.p. pine bears $N63\frac{1}{2}$ °W-19.1' marked BT-E-2-563 X GN-4-554X.

A 10" dead l.p. pine bears S60°W-21.7' with mostly healed blaze.

Description of monument and accessories I established to perpetuate the original location of this corner:

Set $2\frac{1}{2}$ "x30" alum pipe with $2\frac{1}{2}$ " alum cap marked as shown, 24" in the ground and surrounded with mound of stone from which;

A 9" w. fir bears N41°E-28.5' scribed 0-8-552-GN-4-554-E-2-563 BT.

A 16" w. larch bears N82°W-49.1' scribed 0-8-552-GN-4-554-E-2-562 BT.

Each new bearing tree has a brass washer stamped PLS1106 nailed to the face of the blaze. Attached signs 54-3 and 54-9 and painted face of blaze and a 6" red ring around each bearing tree. Set a steel fence posts 3-5' away from monument and attached sign 54-9. Placed remains of wood post on stone mound.

Used steel tape and magnetic staff compass with $20^{\rm O}$ east declination. Measured to center of bearing trees.

This corner was monumented on June 23, 1983.
