## Description of corner evidence found:

At the corner location I found rotted wood in the original post hole S60°W 13.2 ft is a down and rotting 13" Tamarack marked BT N70°E 28 ft is a down and rotting 10" Pine marked S35 BT N30°W 5.3 ft is a root hole where the 10" Tamarack was there is a tree close by but I could see no visible marks.

## Description of monument and accessories I established to perpetuate the original location of this corner:

In the original post hole I set a  $2\frac{1}{2}$ "x32" aluminum capped aluminum pipe 24" in the ground in a mound of stone from which

A 12" White Fir bears S44° E 30.03 ft marked TIIS R35½ E BT nail in N base

Distances pulled to 60d nail with Brass washer stamped LS 1898 driven in the side center of the bearing trees
