
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

This corner was originally established by Horace G. Pearson, U.S Deput y Mineral Surveyor, as part of MS 509 Amended, during March, 1903. The original notes state that at the corner a 4½' long by 4" square marked pine post was set 18" in the ground from which:

A 18" fir bears N76°E-19.'. A 18" pine bears N21°45'W-38.'. Each marked J.P. 3-509 BT.

This corner was remonumented by Leland Myers in 1967.

Description of corner evidence found:

Myers 5/8" by 24" iron pin with $1\frac{1}{2}$ " aluminum cap set in a small mound of stone from which:

A 19" pon. pine stump bears N22°W-38.8' with part of blaze face and frag. scribing visible. A 18" doug. fir stump bears N77°E-19.6' with no remaining scribing.

Description of monument and accessories I established to perpetuate the

original location of this corner:

Set a $2\frac{1}{2}$ " by 30 " aluminum pipe with $2\frac{1}{2}$ " aluminum cap 24" in the ground and surrounded with a mound of earth and stone. Placed Myers' monument inside From the new monument: our new monument.

A 11" pon. pine bears S75½°W-58.7' scribed 3-JP-509AM BT. A 11" pon. pine bears S52°E-18.0' scribed 3-JP-509AM BT.

New bearing trees have a brass washer stamped PLS 1106 nailed to the face of blaze. Attached sign 54-3 and 54-9 and painted face of blaze and a 6" red band around each bearing tree. Set steel fence posts on National Forest Boundary West and South of corner and attached sign 54-9 to one post and sign 54-2 to both posts.

Used steel tape and staff compass with $20^{\circ}\mathrm{E}$ declination, measured to the center of the bearing trees.

This corner was remonumented on October 17, 1985.
