## CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

This corner was originally established by Eugene P. McCornack, U. S. Deputy Surveyor, under Contract No. 398, dated July 2, 1881. The original notes state that at the corner a 14" by 14" by 10" marked basalt stone was set 9" in the ground, from which:

A 36" Pine bears N 60° E - 42 lks., marked:  $\frac{1}{4}$  S BT.

A 36" Pine bears S  $50^{\circ}$  W - 16 lks., marked:  $\frac{1}{4}$  S BT.

## Description of corner evidence found:

None. Spent 2 hours searching with a 2 man crew, including 2 hours PLS time. The corner has been destroyed by the new road to Greenhorn.

Corner was re-established by proportional measure on the East line of T10S R35E, utilizing McCornack's retracement distances for proportioning.

Description of monument and accessories I established to perpetuate the original location of this corner:

The corner falls in the cut bank of the Greenhorn Road, so set a witness corner N  $0^{\circ}$  09' 22" W - 65.00' from the corner position. Set a  $2\frac{1}{2}$ " by 30" aluminum pipe with  $2\frac{1}{2}$ " aluminum cap  $2^{4}$ " in the ground and surrounded with a mound of earth and stone, from which:

A 10" Ponderosa Pine bears S  $74\frac{10}{2}$  E - 31.2', scribed: "X" at breast height and BT at base.

A 14" Ponderosa Pine bears S 20° E - 21.2', scribed: "X" at breast height and BT at base.

New bearing trees have a brass washer stamped PIS 1106 nailed to face of blaze. Attached signs 54-9 and 54-3, and painted face of blaze and a 6" red band around each bearing tree.

Set steel fence post North of corner and attached sign 54-9.

Used steel tape and staff compass with 19 E declination, measured to the center of the bearing trees.

This corner was remonumented on July 11, 1986.
