INDEX No. T-9 History of original corner establishment:

Corner was originally established in 1881, by Herman D. Gradon, under General Land Office Contract No. 416. U.S. Surveyor General's Notes State: Set a post 3 ft. long 3 ins square with marked stone, 12 ins in the ground for 1/4 sec. cor. marked 1/4 S on W. face, dug pits 18x18x12 ins. N & S of post, 5-1/2 ft. dist. and raised a mound of earth 1-1/2 ft. high 3-1/2 ft. base around post.

Description of corner evidence found:

The North Fork of the Burnt River has changes course and destroyed all traces of the original post, pits & mound.

There are no accessories originally established. The proportioned position fits the call in the original notes to the North edge of the River bottom (50.00 ch. Leave river bottom). The position is therefore established at proportionate measure between the Section Corners found 1/2 mi. North & South. Note: The relationship between the call to the River and the edge of the River bottom shows the change in the River course. (See the referenced Map)

Description of monument and accessories I established to perpetuate the original location of this corner:

Set 2-1/2"x30" aluminum pipe with 3-1/2" aluminum cap, stamped as shown on the DIAGRAM, SET in a 30"x5' mound of stone on the South edge of the North bank of the North Fork of the Burnt River. (River is in a deep cut) From Which:

Set 5/8"x30" iron pins with plastic caps marked PLS 848 and guard posts wit: Warning and Bearing Tree signs, as follows:

41'W., 16.7 ft., with one notch filed in the top.

N29⁰09'E., 24.6 ft., pin is not marked. Measurements to pins taken with Electronic Tacheometer with bearings turned from the survey control network.

The Corner is approx. 3' above the high water level, in a deep cut as formed by the River.
