## CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner originally established in 1881 by Herman D. Gradon, U.S. Deputy Surveyor, under Contract No. 416. Surveyor General records state: Set a post 3 ft. long, 3 ins square, 24 ins in the ground, for 1/4 sec. cor. marked 1/4 S on N. face, from which:

A pine 36 ins diam. bears N60°W 49 lks dist. marked 1/4 S BT. A pine 40 ins diam. bears S75°E 114 lks dist. marked 1/4 S BT.

In 1918 USFS Surveyor S. Simms set a basalt stone 15 x 12 x 5 ins. 8 ins. in the ground in a mound of stone 2 ft. base, 6 ins. high marked 1/4 on N. face from which the remains of the original bearing trees: 24" ponderosa pine stump bears N60W, 49 lks. dist with visible scribing.

Indeterminate size ponderosa pine stump bears S75°E, 114 lks. dist. with no visible scribing.

N - 11DIAGRAM T10S R36E S16 S21 1974 (BLM Cap)

In 1974 the BLM set at the corner point an iron post, 28 ins. long, 2 1/2 ins. diam., 22 ins. in the ground, and in a mound of stone, 2 ft. base to top, with brass cap marked as shown in corner diagram from which:
A ponderosa pine, 10 ins. diam., bears N56W, 61 lks. dist., mkd. 1/4 S16 BT.
A ponderosa pine, 6 ins. diam., bears S55W, 36 lks. dist., mkd. 1/4 S21 BT. The corner stone was buried alongside iron post.

Description of corner evidence found:

3 1/4" Brass cap 5" above the ground in stone mound marked as shown in corner diagram from which: 15" Ponderosa Pine, with healed blaze, bears N56W, 61 links distance.

10" Ponderosa Pine, with healed blaze, bears S55W, 36 links distance.

Steel fenceposts 2.8' West with 54-2 sign, 2.3' East with 54-2 sign, and 2.9' South with 54-9 sign.

Corner is 10' South of East-West fenceline.

Description of monument and accessories I established to perpetuate the original location of this corner:

New bearing trees established:

17" Ponderosa Pine bears N45'E 47.0' distance scribed 1/4 S16 BT.

11" Ponderosa Pine bears S26'E 61.2' distance scribed 1/4 S21 BT.

New bearing trees have a brass washer stamped PLS 2672 nailed to face of blaze. Attached 54-3 and 54-9 signs to each bearing tree and painted face of blaze and a 6" band around each bearing tree. The distance is measured to a 50d nail in side center of bearing trees.

Compass declination 18' East.
