

PARTITION PLAT NO. 1996- SURVEYOR'S CERTIFICATE

I, James D. Hanley, hereby certify that I have correctly surveyed and platted the land shown on the annexed minor partition map in accordance with O.R.S. Chapter 92. The boundary of the partition is as follows: That portion of the E1/2NW1/4SW1/4 of Section 3, T. 10 S., R. 37 E., W.M. lying North of Sumpter Valley Highway No. 220, excepting the Easterly 100 feet thereof.

Beginning at the Northwest corner of the said E1/2NW1/4SW1/4, S. 89° 40' E., 657.30 feet from the West quarter corner of said section; thence S. 89° 40' E., 557.30 feet to a point which is 100 feet from the Northeast corner thereof; thence S. 01° 20' 52" E., parallel to and 100 feet Westerly from the East line of said E1/2NW1/4SW1/4, a distance of 1283.87 feet to intersect the Northerly right of way line of the said highway; thence along said right of way line: N. 89° 18' 17" W., 24.72 feet, thence along a spiral curve left, the chord of which bears S. 89° 55' 44" W., 298.01 feet to a point 50 feet right of and opposite centerline Station 479+98.19 P.S.C.; thence along a 3869.72 foot radius curve left to a point 50 feet right of centerline Station 481+00, the chord which bears S. 87° 45' 13" W., 106.64 feet, thence S. 85° 08' 49" W., 128.74 feet to intersect the said West line of the said E1/2NW1/4SW1/4; thence N. 01° 19' 02" W., 1302.23 feet along the said West line to the point of beginning.

NARRATIVE

The purpose of this survey and plat for GERALYN and JACK WILLIAMS is to partition a tract of land shown hereon into three parcels and mark on the ground the corners of each. The description in Deed 94-17-137 describes the tract as "that portion of the E1/2NW1/4SW1/4 of Section 3, T. 10 S., R. 37 E., W.M. lying North of Sumpter Valley Highway No. 220, excepting the Easterly 100 feet thereof." This project required subdivision of Section 3 into its aliquot parts. All quarter section corners, the Southwest section corner and highway centerline reference monuments were found as shown on O.S.H.D. Hwy. Drg. 88-16-14 from which the North right of way line was computed.

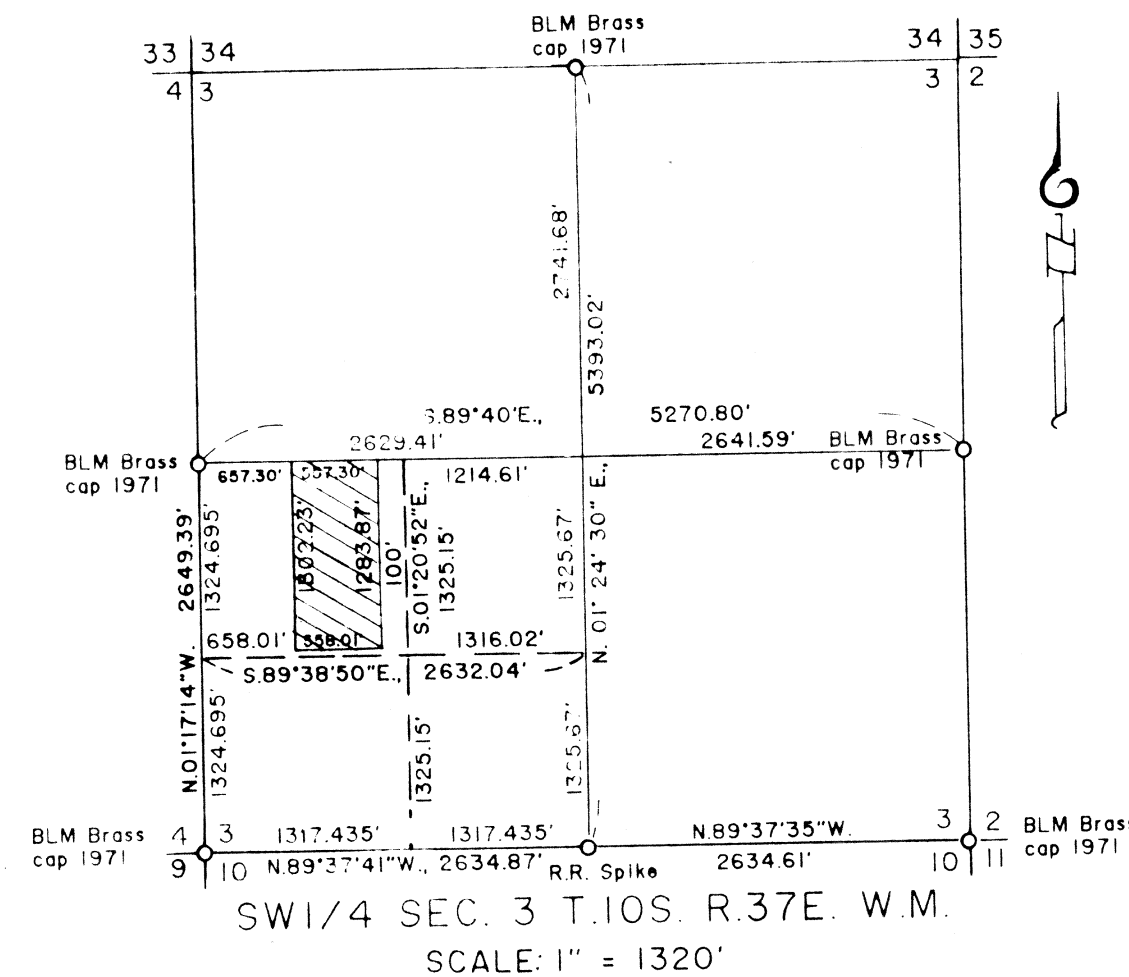

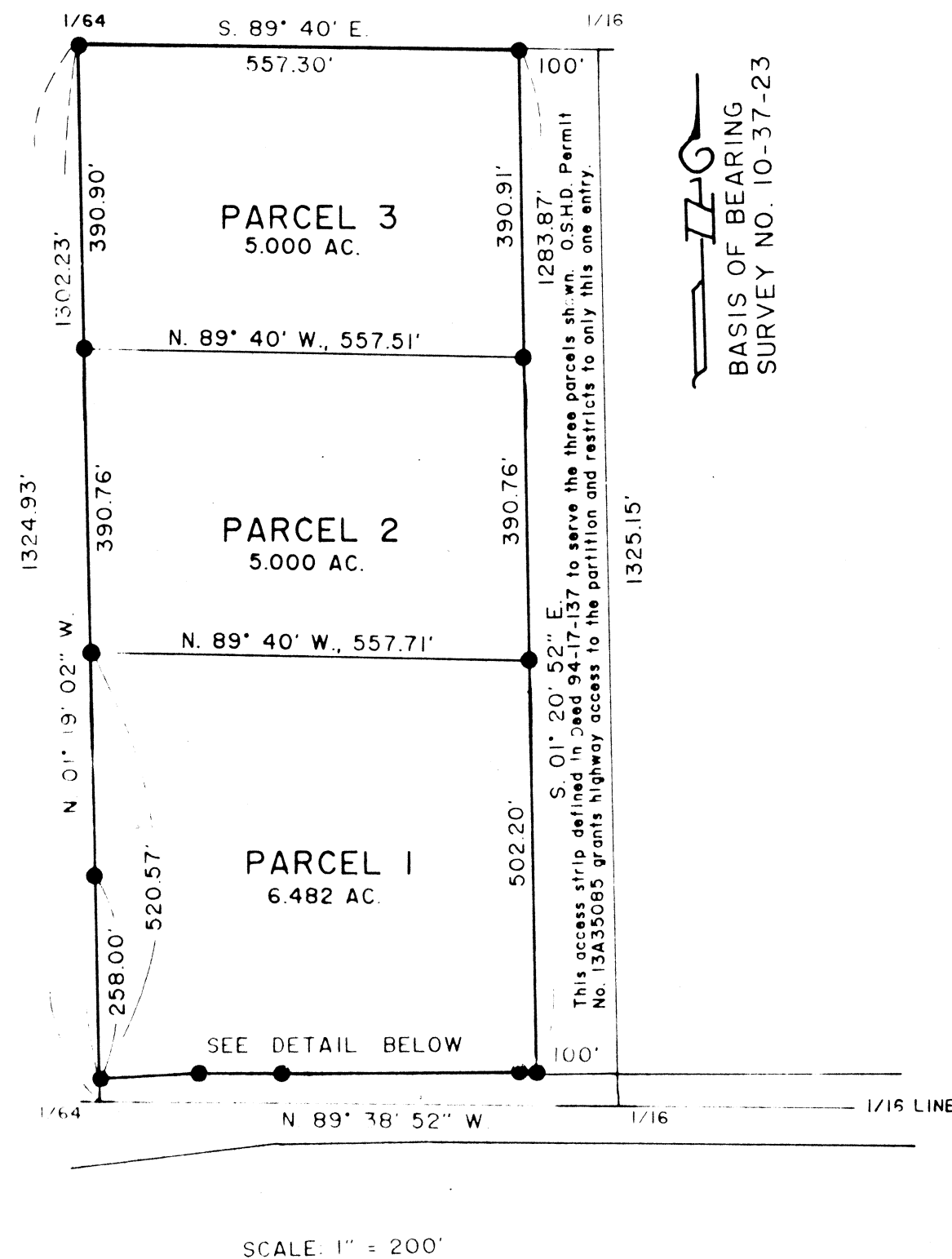

VICINITY MAP

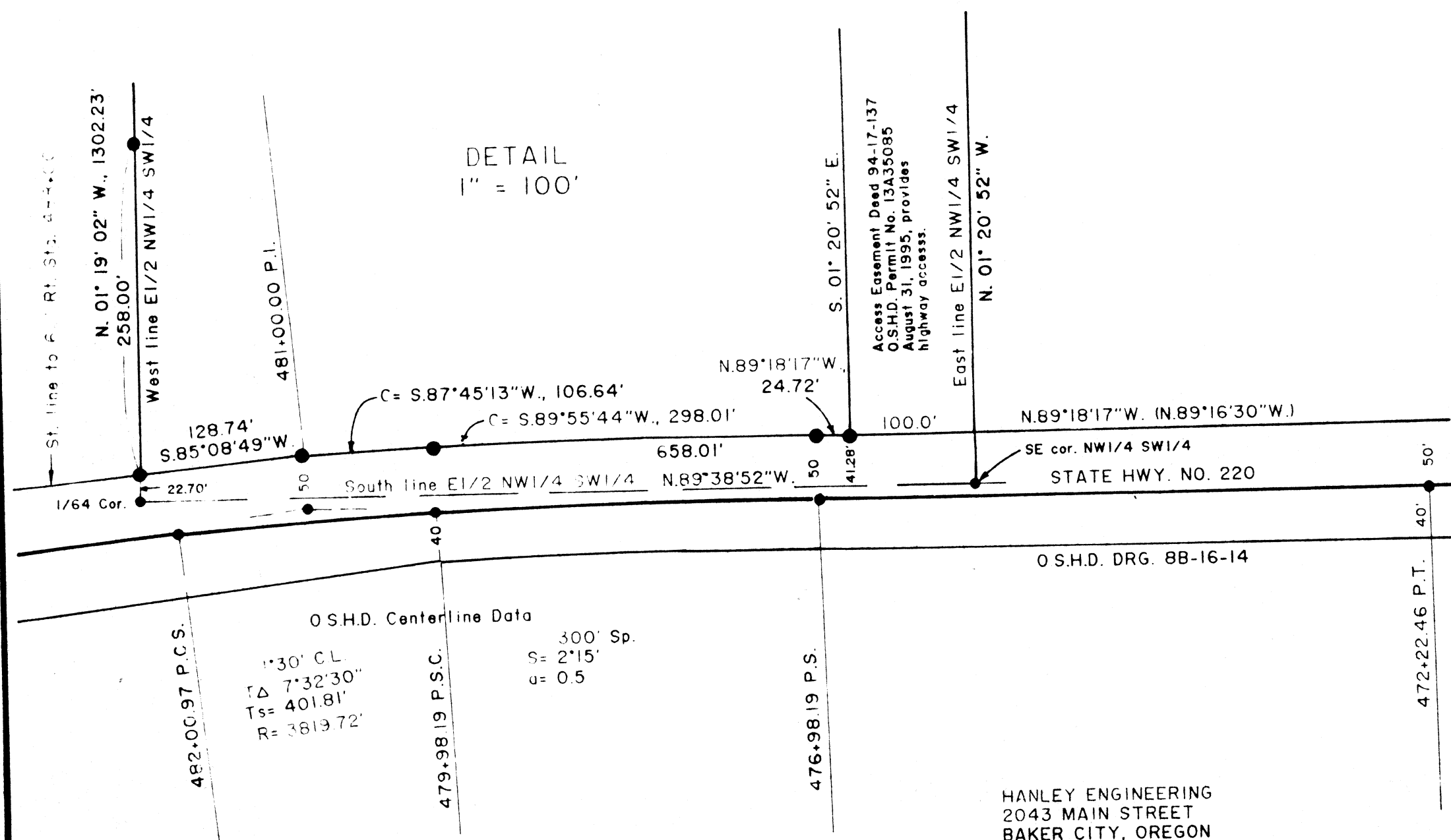
